#### COMAR 13A.12.02.15 (Professional and Technical Education)—Amend/Permission to Publish

Dr. Joann Ericson presented the amended updated version of COMAR 13A.12.02.15 to PSTEB for permission to take it to the State Board for publication. Dr. Ericson stated that there were some changes made to this regulation. The following changes were made.

## **Option III**

- (b) The occupational experience in §A(3)(a) of this regulation shall be within 10 years of the issuance of the certificate and may include:
  - (i) Full-time, satisfactory teaching experience in the career area to be taught; and/or
  - (ii) Full-time, satisfactory occupational experience employment.
  - (iii) The applicant may substitute a Department-accepted, current industry recognized credential, a list of which is maintained by the Department, for 1 year of the occupational experience requirement.

#### **Option IV**

(b) The occupational experience in \$A(3)(a) of this regulation shall be within 10 years of the issuance of the issuance of the certificate and may include:

- (i) Full-time, satisfactory teaching experience in the career area to be taught; and/or
- (ii) Full-time, satisfactory occupational experience employment.
- (iii) The applicant may substitute a Department-accepted, current industry recognized credential, a list of which is maintained by the Department, for 1 year of the occupational experience requirement.

#### COMAR 13A.12.02.16 (Work-based Learning Coordinator) – Amend/Permission to Publish

Dr. Joann Ericson presented the amended updated version of COMAR 13A.12.02.16 to PSTEB for permission to take it to the State Board for publication. There were some minor changes made to this regulation. The following changes were made.

- B. (1) Hold a professional certificate with certification under COMAR 13A.12.02.06, .13, .15, and .17—.20(A)(3) of this chapter.
- B. (3)(a) Documented evidence of employment equivalent to minimum of 1,000 hours of satisfactory, wage-earning, nonteaching occupational experience;
- B. (3)(b) Documented evidence of employment equivalent to a minimum of 1,000 hours which shall include 500 hours of satisfactory, wage-earning, nonteaching occupational experience and 500 hours of self-employment.

#### Request from the Maryland School for the Deaf

Dr. Joann Ericson presented to the Board letter from the Maryland School for the Deaf, requesting that a workgroup be convened to revise the certification requirement for the teachers of the Deaf and Hard of Hearing. Dr. Ericson stated that a similar request was done for the Maryland School for the Blind.

Dr. Ericson stated that the major concern is that MSD teachers who move to Maryland from out of state are faced with obstacles in acquiring their teacher certificate in Maryland.

### **Discussion**

# Panel: Assessment Systems for Pre-service Teachers

Dr. Saroja Barnes, Branch Chief, MSDE Program Approval and Assessment Branch

- Indicated that there are ongoing conversations and considerations by PSTEB and MSBE regarding the preparation of teachers in Maryland approved programs, particularly elementary teachers, to develop deep content and pedagogical content knowledge, to differentiate instruction and support learning in diverse PK-12 classrooms, teach to MCCRS and implement high quality SLOs.
- The process for teacher prep program approval in Maryland, both IHE based (MAPs) and alternative
  pathways (MAAPPs) requires programs to demonstrate they met standards established by CAEP
  (national accrediting agency), as relevant, Maryland Institutional Performance Criteria (IPC), and
  Professional Development Schools standards.
- The emphasis in the review process is on evaluation of valid and reliable evidence of outcomes; evidence that demonstrates teacher candidates have actually *learned* what programs claim to teach.
- Panelists shared some of the ways performance-based assessments are being used in their programs and in others in the state to ensure teacher candidates are ready for the classroom.

## Use of e-portfolios to collect teaching artifacts: McDaniel and Lessoncast

- Currently working with BCS to support development of CPD courses that require teacher produced evidence to demonstrate effectiveness in meeting performance standards
