- Granted permission to adopt amendments to 13A.03.02 *Graduation Requirements for Public High Schools in Maryland,* which include updates replacing the science assessment for HSA Biology and clarifying language.
- Granted permission to publish amendments to 13A.03.04 *Test Administration and Data-Reporting Policies and Procedures,* which 1) updates COMAR 13A.03.04.02 to clarify that "local school system" includes special schools and nonpublic schools approved under COMAR 13A.09.10 that use tests administered on behalf of the State Board; 2) updates COMAR 13A.03.04.03 to prohibit the use of electronic devices (unless used for testing or administrative purposes) in testing rooms during testing, clarifies the information needed for an archival document of testing groups, specifies what the data reporting policy should include, and allows for electronic signature of forms and agreements; and 3) updates COMAR 13A.03.04.04 to clarify that local school systems must designate a Local Accountability Coordinator and a School Test Coordinator, and outlines the general duties of each.

## **Legislative Update**

Mr. Patrick Fleming provided the PSTEB Board with a brief legislative update on HB493/SB638. HB493 and SB638 both requires that the Professional Standards and Teacher Education Board (PSTEB), by January 1, 2022, to require specified teaching candidates to successfully pass a written test of research-based reading instruction. This only applies to candidates applying for a certificate to teach students with disabilities, as a reading specialist, English language learners, as a reading teacher, or prekindergarten through sixth grade. PSTEB and the State Board of Education jointly must (1) select the test by January 1, 2019; (2) set the passing score at least as high as the level recommended by the test developer; and (3) set standards that include specified elements for the delivery of research-based reading instruction by teacher preparation programs in the State. He informed the board that neither of the bills have a hearing date yet. Mr. Fleming told the Board that if they oppose the bills, that they could write a letter for him to present to the legislation.

After thoroughly discussing the two bills, the Board decided to take opposition to HB493 and SB638. It was decided that the Board would write a letter of opposition. Ms. Spross stated the Board will do as it has done in the past, pull together information and write a letter. Once the letter is written, Dr. James will approve, sign and send the letter to Mr. Fleming to submit to Annapolis.

Adjunct Certificate - COMAR 13A.12.01.08-1 - Promulgate - Permission to Publish

**Purpose** 

The purpose of this items is to request permission to publish the promulgation of new Code of Maryland Regulations (COMAR 13A.12.01.08-1 *Adjunct Certificate* (Attachment I). New regulatory language is being introduced to provide local education agencies (LEAs) the ability to request an adjunct certificate for individuals with highly specialized content expertise (e.g., engineers, physicists, medical providers, artists) who are interested in teaching on a part-time basis, in the classroom as a teacher of record.

### **Proposed Amendments:**

The proposed regulatory language establishes the eligibility criteria for the issuance of the certificate, requires the LEAs to provide specific support and professional development to an individual who holds an adjunct certificate, and establishes the limitations of the certificate. The following criteria define the professional development and support a LEA would be required to provide to an individual who holds an adjunct certificate.

## Eligibility Criteria:

- Hold a minimum of a bachelor's degree from an accredited university/college
- Hold industry licensure, when applicable, for that profession
- Have five years of successful experience in the field

Local education agencies (LEA) would be required to provide the following to those individuals who hold an adjunct certificate:

- Mentoring
- The opportunity to participate in side by side coaching or co-teaching with a professionally-certified educator and professional development prior to entry into the classroom and throughout the school year
- Regular evaluations

#### Certificate limitations:

- Non-transferable
- Part-time
- One-year validity period
- Renewable, upon the request of a LEA
- Issued by the MSDE

### **Summary**

New regulatory language COMAR 13A.12.01.08-1 is being proposed to address the LEAs continuing need to hire individuals with highly specialized content expertise, whom are interested in teaching on a part-time basis, as a teacher of record. Specific regulatory language establishes the eligibility criteria for the issuance of the certificate, requires the LEAs to provide specific support and professional development to an individual who holds an adjunct certificate, and establishes the limitation of the certificate.

# Options for Obtaining Initial Maryland Certification COMAR 13A.12.01.04

## **Purpose:**

The purpose of this item is to request permission to publish amendments to Code of Maryland Regulations (COMAR) 13A.12.01.04 *Options for Obtaining Initial Maryland Certification* (Attachment 1). #### **Purpose:**

Amendments are being proposed to allow those individuals seeking certification who do not hold a bachelor's degree (i.e., specialized professional areas and professional technical education candidates) to have the ability to present credit bearing coursework to fulfill the basic skills requirement in lieu of an assessment.

### **Proposed Amendments:**

The regulatory amendments allow those individuals seeking certification who do not hold a bachelor's degree (i.e., specialized professional areas and professional technical education candidates) to have the ability to present credit bearing coursework to fulfill the basic skills requirement in lieu of an assessment.

#### **Summary:**

Proposed amendments to COMAR 13A.12.01.05 *General Requirements for Professional Certificates* allow those individuals seeking certification who do not hold a bachelor's degree (i.e., specialized professional areas and professional technical education candidates) to have the ability to present three semester hours of credit bearing coursework in Math and three semester hours of credit bearing coursework in English Language Arts to fulfill the basic skills requirement in lieu of an assessment.

## **Workgroup Updates:**

## **Teacher Preparation/Certification Workgroup**

Ms. Spross stated that there were three members of PSTEB identified to meet with three members of the State Board. The PSTEB members are Dr. Kandace Hoppin, Mr. Darren Hornbeck and Dr. Alyssia James and the members of the State Board Dr. Chester Finn, Ms. Stephanie Iszard and Dr. David Steiner. The two groups are to meet about "All Things Teacher Preparation/Certification". The three members of the State Board have had some preliminary meetings amongst themselves and Ms. Spross had been contacted to provide information.

At this juncture, no decisions have been made and they are not making any decisions. The State representatives are educating themselves about teacher preparation and certification in Maryland. It is more leaning towards teacher preparation. The materials that were gathered are: the current IPC, the recommended amended IPC from the workgroup, the Professional Development school manual, the Professional Development framework, the and Professional Development school Indicators along with the Praxis test scores and test rates. So far, the materials have been a collection of what we currently have so that they can understand the baseline. Hopefully by the end of February, early March the group would be ready to start digging into the actual work. The group needs to identify the standards by which teacher education programs are going to be approved under.

### **Superintendent Workgroup**

Representatives for the workgroup are Dr. Alyssia James (PSTEB); Dr. Justin Hartings (State Board); Dr. Teresa Albin (PSSAM); Mr. Bill Middleton (MAEP); Sister Sharon Slear (MECUA); Dr. Jennifer Rice (USM); Ms. Megan Kelly (MAPSA); Ms. Sarah Spross, Ms. Kelly Meadows, and Mr. Derek Simmonsen. The group has met two times so far, late November and January. A third meeting is scheduled for March.

The workgroup is looking at superintendent certification and amendments. So far the group has addressed the minimum qualifications to become a superintendent, options in for out-of-state individuals (which does not exist at the present time), and the language. Ms. Spross stated that it use to be two regulations for superintendent as well as the deputy superintendent, associates and assistants. The workgroup has made the decision that they are only addressing superintendent with this regulation. Probably a second workgroup will be formed to look at what should be in line for the other superintendent positions. The workgroup has been very concerned about what they had perceived the regulations to be for a superintendent. It was identified at the meeting that it was more difficult to be a principal than a superintendent based on the plain language of the regulations. Ms. Spross feels that we will see some changes to the language as the group moves forward. There are some key people at the table.

## **Proposed Mentoring Regulation**

Ms. Spross informed the Board that Ms. Cecilia Roe, in the Division of Curriculum, Assessment, and Accountability oversees Professional Development/Mentoring. She stated that PSTEB could look at the regulations and send a letter to Ms. Roe, but we do not have the authority to change them.
