EMPLOYEE OF THE MONTH!

MSDE is proud to announce our May 2017 Employee of the Month:

Teresa Lewis



Teresa is a Child Care Licensing Supervisor with the Division of Early Childhood Education (DECD), Office of Childcare - Licensing Branch, Region 3 in Baltimore County. She was nominated by her Branch Chief, Paula Johnson.

Teresa Lewis consistently performs above and beyond expectations. The Licensing Branch licenses child care providers who provide out-of-home care for children in Maryland. All regulatory activity is conducted through thirteen regional offices statewide. Child Care provider case files are managed and tracked in a Child Care Automated Tracking System (CCATS), and inspections of the Child Care facilities are conducted using an Electronic Licensing Inspection System (ELIS). These databases are the major, and most critical, tools used by licensing staff to perform their duties.

On her own initiative, Teresa took the time to become \Rightarrow extremely knowledgeable of the data systems. In addition to performing her supervisory duties, Teresa consistently volunteers her knowledge and skills in finding solutions to technology issues that arise within the CCATS and ELIS data systems. As a member of the CCATS and ELIS super user groups, she evolved as a leader, often leading group discussions during meetings. In April, she convened the meeting of the CCATS super users in the absence of the project manager.

Teresa has provided valuable input into the roll-out of a major CCATS modification and planned modifications for the ELIS system in the following ways:

- Tested modifications and provided valuable information to the project managers and vendors in the development of system requirements, and to the Branch Chief in developing policy relative to the systems;
- Led efforts to train more than 100 licensing staff statewide in the new processes;
- Leading a team of 2 others, she traveled to regional offices conducting training sessions to ensure that staff understood the new processes;
- Completed the major training in one month; and saved MSDE staff development training dollars.

- Approved Carroll County Public Schools' request to waive one day of student attendance for the 2016-2017 school year.
- Welcomed new Board member Dr. David M. Steiner. Dr. Steiner was appointed by the Governor to serve the remainder of the term of Jannette O'Neill-Gonzales. Ms. Gonzales resigned from the State Board in December, 2016.
