RE: 2018_p152_MSDE_BOOST Recommendations

Dear Chairman Kasemeyer and Chairman McIntosh:

This letter is submitted in accordance with the requirements on page 152 of the Fiscal 2019 Joint Chairman's Report (JCR) to provide information on the Broadening Options and Opportunities for Students (BOOST) program. The JCR requires that the BOOST Board make recommendations regarding a policy to encourage nonpublic schools to admit students with special needs who receive BOOST program scholarships.

The BOOST Board discussed servicing the needs of special education students at several Board meetings during 2018. At a June meeting, the Board received a presentation from the Assistant State Superintendent for the Division of Early Intervention and Special Education Services at the Maryland State Department of Education (MSDE), which included information on the federal Individuals with Disabilities Education Act (IDEA), the process for identifying students with disabilities, and equitable services; federal funding for students with disabilities who attend nonpublic schools.

The Board's discussion centered on several key points: meeting the needs of students in the most appropriate manner and the best interest of the entire program. The Board feels strongly that children should get what they need to be successful in school in the most appropriate setting for the child. Students who are parentally placed in a nonpublic school have an individual service plan (ISP) that is cooperatively developed between the parents, the public school, and the nonpublic school. While there is no requirement that students with disabilities receive the same services in a nonpublic school that would be provided in a public school, the ISP process identifies the services needed by the student, the services that can be provided, and the proportionate share of federal funds that can be used to support those services. In most cases, students receive related services, i.e. speech/language therapy, occupational therapy, physical therapy, through this process, and not academic services. The Honorable Edward J. The Board also discussed the impact of any recommendations on parents and families, and schools that participate in the program. Currently, participating schools may not charge more in tuition than the state average cost per pupil, as calculated by MSDE. Participating schools calculate tuition rates as total tuition revenue divided by total students. This calculation accounts for the varying tuition rates at

Individual schools, such as family and staff discounts, and additional costs for supplemental programs. Participating schools cannot receive more BOOST scholarship aid than the tuition rate. A recommendation to provide a large subsidy for special education students to attend nonpublic schools could result in returned, unused funds from schools. At its July 2018 meeting, the BOOST Board determined that students eligible for special education services should receive a \$1,000 adjustment to their scholarship award.

The 2018-2019 BOOST application allows parents to self-identify children as eligible for special education services. The 2018-2019 school enrollment confirmation process requires schools to confirm a student's eligibility for special education services and to provide the vehicle used to identify the student as a student with disabilities as well as the services that the student will receive. For the 2018-2019 school year, 251 scholarship awards were made to children whose parent identified the student as eligible for special education services. As of November 8, 2018, nonpublic schools confirmed that 145 BOOST scholarship recipients are eligible for special education services. These students reside in 13 counties across the State and attend 44 different nonpublic schools. The largest number of students are from Baltimore City, followed by Baltimore County, and Prince George's County. The following attachments illustrate the BOOST program awards and enrollment confirmations for students eligible for special education services.
