RE: 2019 p176 MSDE Broadening Options and Opportunities for Students Today (BOOST)

Dear Senator Guzzone and Chair McIntosh:

This letter is submitted in accordance with the requirements on Page 176 of the Fiscal 2020 Joint Chairmen's Report (JCR) to provide information on the Broadening Options and Opportunities for Students Today (BOOST) program.

The JCR requires that the Maryland State Department of Education (MSDE) submit information by January 15, 2020 on:

- the number of students receiving BOOST Program scholarships;
- the amount of the BOOST Program scholarships received;
- the number of certified and noncertified teachers in core subject areas for each nonpublic school participating in the BOOST Program;
- the assessments being administered in accordance with federal and State law by nonpublic schools participating in the BOOST Program, and the results of these assessments. MSDE shall report these assessment results reported by nonpublic schools to the budget committees in an aggregate manner that does not violate student data privacy;
- in the aggregate, for each BOOST Program scholarship awarded:
 - o the nonpublic school and grade level attended by the student;
 - o the school attended in the 2019-2020 school year by the student; and

- if the student attended the same nonpublic school in the 2018-2019 school year, whether, what type, and how much nonpublic scholarship aid the student received in the 2018-2019 school year and will receive in the 2019-2020 school year;
- the average household income of students receiving BOOST Program scholarships;
- the racial breakdown of students receiving BOOST Program scholarships;
- the number of students designated as English language learners receiving BOOST Program scholarships;
- the number of special education students receiving BOOST Program scholarships;
- the county in which students receiving BOOST Program scholarships reside;
- the number of students who were offered BOOST Program scholarships but declined them, as
 well as their reasons for declining the scholarships and the breakdown of students attending
 public and nonpublic schools for students who declined scholarships; and
- the number of students who received BOOST Program scholarships for the 2017-2018 school year who are attending public school for the 2018-2019 school year, as well as their reasons for returning to public schools.
- The number of students who received BOOST Program scholarships for the 2017-2018 school
 year who withdrew or were expelled from the nonpublic schools they were attending; the
 reasons for which they withdrew or were expelled; the schools they withdrew or were expelled
 from; and the length of time students receiving BOOST Program scholarships were enrolled at
 a nonpublic school before withdrawing or being expelled.

BOOST ASSESSMENT PERFORMANCE 2018-2019 RESULTS

Methods

The MSDE collected SY 2018-2019 assessment performance data from nonpublic schools via a secure online application.

The data presented in this report is self-reported by participating BOOST nonpublic schools and is not subject to a thorough verification and audit process by the MSDE. These results should be interpreted with caution. Each school was obligated to assess students, but the assessments administered and the determinations of proficiency were at the discretion of each individual school.

Maryland law requires the MSDE to report results in a manner that does not violate student data privacy. A '*' indicates no students or fewer than 10 students in category, or '*' indicates the percentage for the category is either ≤5 or ≥95 and the corresponding counts have been suppressed.

Data not included in analysis

Assessment results were excluded from the summary tables if the assessment name was reported as 'none' or 'missing'. Please note that some schools reported on results for an approved assessment for some contents but 'none' or blank for other contents. In these situations, all results reported using an approved assessment were included in the analysis. We only excluded results if the assessment name was 'none' or 'missing'. There were 7 schools that reported 'none' or 'missing' for all reported contents. Data for those schools (n = 7) were removed from all analysis.

A number of results were excluded from the analysis due to assessment name = none/missing:

For ELA: This impacts data for 6 schools; 24 reported BOOST students and 313 reproted non-BOOST students For Math: This impacts 5 schools; 29 reported BOOST students & 325 reported non-BOOST students For Science: This impacts 13 schools; 28 reported BOOST students & 437 reported non-BOOST students

The final dataset included 153 unique schools but data for all 3 contents were removed for 7 schools because each content had an assessment name of 'none' or 'blank'. This results in the 146 total unique schools in the summary table.
