<u>COMAR 13A.12.04.03 – Superintendent (Repeal and Replace – Permission to Publish)</u> - Attachment II

<u>COMAR 13A.10.01.06-1 – Extraordinary Career Leader Certificate (Promulgation - Permission to Publish)</u> - Attachment III

Purpose:

The purpose of this item is to request permission to publish amendments to the Code of Maryland Regulations (COMAR) 13A.12.04.03 *Superintendents* (Attachment II) and to publish the promulgation of COMAR 13A.12.01.06-1 *Extraordinary Career Leader Certificate* (Attachment III).

Amendments to *Superintendents* are being proposed to provide additional pathways to certification in the area of superintendent as well as to establish two, distinct superintendent certificates: Superintendent I for Deputy, Assistant and Associate Superintendent; and Superintendent II for Superintendents.

Promulgation of a new regulation for the *Extraordinary Career Leader Certificate* is being proposed to create the new Extraordinary Career Leader Certificate, as recommended by the Joint Conference Committee, for those individuals with an exceptional background and skills to be considered for a Superintendent position.

Proposed Amendments:

The proposed amendments:

- Delineate the requirements set forth for certification as a superintendent (Superintendent II) and the requirements set forth for certification as a deputy, associate, and assistant superintendent (Superintendent I).
- Expand the pathways to become a Maryland Superintendent to include traditional preparation: from in-state and out-of-state institutions of higher education and reciprocity for those that hold a Superintendent Certificate from another state; and
- Create a new certificate called the Extraordinary Career Leader Certificate that allows an
 individual with an exceptional background and skills to be considered for a Superintendent
 position in a local education agency.

Summary:

A workgroup comprised of multiple constituent organizations recommended proposed amendments to COMAR 13A.12.04.03 Superintendents to establish two, distinct superintendent certificates, as well as provide multiple pathways to certification. The SBOE and PSTEB, through a Joint Conference Committee meeting, expanded the recommendations of the workgroup to include reciprocity and the creation of the Extraordinary Career Leader Certificate that allows an individual with an exceptional background and skills to be considered for a Superintendent position.

Action:

Request permission to repeal, replace, and publish amended regulatory language to COMAR 13A.12.04.03 *Superintendents*.

Request permission to promulgate and publish new regulatory language to COMAR 13A.12.01.06-1 *Extraordinary Career Leader Certificate*.

After a thorough discussion by the PSTEB and questions to Mr. Derek Simmonsen about what the next steps were, a motion was entertained.

Discussion

Ms. Spross presented the recommendations of the State Board to the PSTEB members. The members did not agree with the *Extraordinary Career Leader Certificate*. Both the SBOE and the PSTEB agreed that the requirements for superintendent I and Superintendent II address the concerns with the current regulations and create a career ladder for superintendent. All of the PSTEB members clearly expressed their concern in regards to letter "C" (Extraordinary Career Leader Certificate) requirements. Specific concerns include:

- Local Boards do not want this.
- The need for leadership with PreK-12 experience.
- Would the State Board approve someone like this for State Superintendent?
- Teachers would not respect an individual without experience in education.
- The need for stability in a superintendent and the one year interim period does not promote stability
- Credit count is a back door way to get in the position.
- Question if this decision propels Maryland forward or moves it backwards
- Agree that the Superintendent I and II address the problems with the current regulation

After a thorough discussion and getting clarification from Mr. Derek Simmonsen on what the next steps would be, a motion was entertained by the PSTEB.
