#### I. Background

The Maryland Safe to Learn Act of 2018 (Md. Code Ann., Education Art., § 7-1510) requires that on or before June 15, 2019, and regularly thereafter, each Maryland local school system **conduct a safety evaluation of each public school** under the local school system's jurisdiction to:

- 1. Identify and, if necessary, develop solutions for physical safety concerns, including issues with building security; and
- 2. Identify and evaluate any patterns of safety concerns on school property or at school- sponsored events.

The law also requires that in performing the safety evaluations, each designated safety coordinator shall:

- 1. Consult with the Maryland Center for School Safety (MCSS) for guidance;
- 2. Coordinate with the Interagency Commission (IAC) on School Construction facility assessment process; and
- 3. Submit the completed safety evaluations to the MCSS.

#### II. Purpose

The purpose of this grant is to provide funding to local school systems (LEA) for conducting the required safety evaluations for each public school. The MCSS administers the grant funds and determines awards. This NOFA outlines the steps for **LEAs** to apply for funding under the program.



## III. Application Instructions

- A. All fields of the application must be completed (unless otherwise indicated).
- B. Completed applications must be emailed to <u>mcss.mcss@maryland.gov</u>.
- C. Completed applications must be received by the MCSS by **February 28**, **2019** to qualify for funding. Applications should not exceed 10 pages, must use a minimum of 12-point font and a minimum 1.5 line spacing.

#### **IV.** Supplanting

School Safety Survey Grants must be used to supplement existing State, local or private funds for program activities and must not replace those funds that have been appropriated for the same purpose.

#### V. Evaluation Criteria


