The Serial Assault /HIV Grant is going toward a more general focus because similar skills are needed.

<u>Public Relations / Awards: David Zauche, Chair.</u> The marketing project is on hold. David Zauche and Joan Stine, of the Awards Committee invite additional members. Nominees will be carried over from last year. Other types of awards are being considered.

<u>Local School Health Councils: Genie Wessel, Chair.</u> Letters were sent to interested people. Methods of reporting usage are being sought.

HB 397 Disclosure of Pesticide Application Information. Strongly supported by PTA. Routine spraying is considered inappropriate by many environmentalists. Our Environmental Health Committee should advise. A fact sheet could be helpful.

Ms. Behrens reviewed potential changes in the organizational structure and positioning of OCYF. OCYF may become a department and have an advisory and policy role. The systems reform initiative was discussed. Ms. Behrens encouraged public input at the upcoming hearings. Maryland Making the Grade will continue to exist. Talbot and Montgomery counties will be offered funding for school-based health centers at \$800,000 over four years. Each site will receive \$100,000 per year to provide comprehensive services to address barriers to education.

Medicaid Reform

Proposed new regulations offer "adjacent" clinics. OCYF opposes off-site clinics for many reasons. The safety of students cannot be assured when leaving campus, there are potential problems with MCO's providing services rather than independent community/school providers.

By-Laws

Proposed changes were reviewed. We may need to take a mail vote since attendance at the meeting is low.

Meeting with Dr. Grasmick

Dr. Fine met wit Dr. Grasmick, Debbie Somerville, Harriet Highsmith on September 20. Topics of the discussions are included in today's packet. The relationship of LHD's and LEA's in school

health services was discussed. The concern was raised that health education has no oversight, that there is lack of support and technical assistance for health education at MSDE. Dr. Grasmick committed to include health education into the testing structure. The MSSHC may need a representative on the Governors pesticide task force in the Department of Agriculture. 140 million dollars is available for renovation. Air quality standards were discussed. Dr. Grasmick would like us to testify at the Systems Reform Initiative and Medicaid reform hearings. Dr. Grasmick wants to utilize high tech learning (e.g. satellite) to involve local level staff. Joan Stine will pursue this topic.

Infants and Toddlers Program

The future "home" of Infants and Toddlers is an issue. Currently the program is in OCYF who will have responsibility for the program in the future. A concern is how to keep the program collaborative vs. categorical.

Meeting with Dr. Wasserman Dr. Fine will pursue a meeting with Dr. Wasserman.

Annual Report
The annual report is included in todays packet.

ASHA MEETING

Dr. Fine is to attend the ASHA meeting at the end of October. On his agenda are proposals to update ASHA policies and position papers, establish a clearing house on successful programs in school health, resources, and training opportunities, and asking the executive committee to pursue collaborative agreements with related national organizations with an interest in comprehensive school health.

The meeting was adjourned at 3:35.

Plans are being made for the Spring, 1997, Conference to be held April 17 - 18, at Solomons.

Health Services: Chair will be selected. (No report.)

Health Education: Russell Henke, Chair. (No report.)

Environment: Kathy Mansberger, Chair. (No report.)

<u>Public Relations and Awards: Chair will be selected.</u> The Spring, 1996, awards recipients were Rose La Placa, Paula Hollinger, Mary Etta Reedy and Bunny Rosenthal.

A motion was made by Russell Henke, seconded by Teresa Albright, that the MSSHC leadership award be named The Dr. John M. Krager Leadership Award, in memory of Dr. Krager, who dedicated his life to improving the health of children and who was deputy director of the Baltimore County Department of Health at the time of his death this summer. <u>Public Relations / Awards: Joan Stine, Chair.</u> The committee is pleased with the several awards which were presented. It was suggested that candidates be selected from a larger circle, including promoters and legislators who work for the advancement of health education issues. Structure of awards will be considered; certificates of appreciation can be included.

Program: Michael J. Schaffer, Chair. The Fall Meeting for Executive Board and General Body Members will be held on November 10, 1993. Program consideration: Legislation regarding youth access to tobacco. Suggested format to include two sessions each, for morning and afternoon; may include speaker at lunch. Joan Stine gave an update on the state-wide Smoking Coalition led by Dr. Wasserman. OLD BUSINESS

American School Health Association: Only 18 of our members belong to ASHA - insufficient for voting rights on the Board of Governors. Dr. Krager will represent us at ASHA this year, meeting in Pittsburgh.

<u>School Nurse Institute Program:</u> Approximately 115 attended the SNIP skill-building sessions. Dr. Krager was on the program. Shirley Steel presented the address.

Wellness Conference: Michael Schaffer reported that 290 paying attendees participated in the July 25 - 30, 1993 conference. Program: Alcohol and Drug Prevention. Every county was represented. MSDE voted to support it. The Maryland Wellness Foundation is applying for a conference grant. Next conference will be July 24 - 29, 1994.

NEW BUSINESS

Robert Wood Johnson Foundation Grants for school-based health centers will come through the state to the counties. only five counties have been included so far. The first year will be for planning Grants will be for ten states: four sites per state in two subdivisions. \$124,000 /year/site.

<u>Program Award for Fall Meeting:</u> Letters will be sent to superintendents, health officers and Council members.

The Maryland Health Education Consortium Fall Summit (planned by the Governor's Committee) will be on November 30, 1993, at the University of Maryland, Adult Education Center.

Health Summit (state-wide), planned by the Cancer Society will be at the Sheraton, Ocean City, May 2 - 4, 1994. Focus: Comprehensive School Health. MSSHC will have a business meeting first; our Spring Meeting will be on May 4, 1993, including a luncheon, keynote speaker, and meeting summation. After the session, the Executive Board will meet.

Meeting with Dr. Grasmick and Mr. Sabatini will be planned with Shirley Steel and Dr. John Krager.
