DEI/SES Guidance During the COVID-19 Pandemic: Marcella E. Franczkowski. Assistant State Superintendent, Division of Early Intervention and Special Education Services (DEI/SES) met virtually with the SESAC to provide an overview and updates regarding the State's work to support students with disabilities and their families, local school systems, public agencies, and nonpublic schools in the wake of the COVID-19 pandemic. She commended the Developmental Disabilities Council, Parents' Place Maryland, and the advocacy community for all their support throughout this pandemic. She reviewed the expectations put forward by Dr. Karen Salmon and Governor Hogan for a "Continuity of Learning for all students," she summarized expectations for local school systems, continuum of teaching and learning, and provided updates regarding no waivers to IDEA (except for transition from Part C to Part B). Ms. Franczkowski reviewed a flow chart providing clear expectations of expectations and process for beginning recovery efforts. She opened the lines for Q&A to discuss varying models of recovery to address individualized needs for instruction and learning. At this time, parents and local school systems acknowledge the unknown of recovery plans and the timing to begin this recovery.

Certificate of Completion Workgroup: Pamela Talley has been the SESAC representative on the workgroup and provided updates to the SESAC, including recommendations to MSDE.

SESAC Annual Report: Pamela Talley provided a copy of the SECAC Annual Report to the SESAC, opening a discussion to finalize recommendations for the Assistant State Superintendent.
