

#### **Maryland Safe to Learn Act-2018**


- □ Senate Bill (SB) 1265, Maryland Safe to Learn Act of 2018, passed the General Assembly on the final day of the legislative session was signed into law by Governor Larry Hogan (Chapter 0030)
- □ SB 1265 consists of the following tenets:
  - Maryland Center on School Safety (Under the auspices of the Maryland State Department of Education).
  - Behavior Threat Assessment Teams/Behavior Threat Assessment Model Policy.
  - School Safety Coordinators, Safety Evaluations, and Emergency Plans
  - School Resource Officers
  - School Emergency Drills
  - School Mental Health Coordinators, Services, and Responsibilities
