SUBJECT:	State Legislative Update

PURPOSE:

The purpose of this item is to provide a legislative overview and status of issues related to education that are currently before the 2018 General Assembly. Please find attached a synopsis of several pieces of significant legislation that have been introduced since the opening of the 2018 legislative session.

EXECUTIVE SUMMARY:

Patrick A. Fleming, Director of Education Policy and Government Relations will update the members of the State Board of Education on the status of significant legislation that has been introduced during the 2018 legislative session.

Maryland State Board of Education Legislative Synopsis As of March 9, 2018

House

HB 10 (Walker) State Lottery – Unclaimed Prizes – Public Prekindergarten Programs

The bill would disperse unclaimed prize money to County Boards of Education to supplement existing funding for pre-kindergarten programs. The funding shall be distributed on a pro-rated basis determined by the total lottery sales made in each County.

Hearing Date – 01/17/2018

HB 23 (Long) - Baltimore County - Public Schools - Active Assailant Event Training Drills

The bill would require active assailant event training for all school personnel annually, and each school will need to conduct active assailant event drill three times each school year.

Hearing Date - 02/01/2018

HB 30 (Angel) – Domestic Violence – Education and Definition of Abuse

The bill adds "domestic violence" to the list of subjects the Board is to encourage LEAs to incorporate into their health education curriculum. Also, the bill adds "harassment" and "malicious destruction of property" to the definition of abuse and creates definitions for each.

Hearing Date - 01/18/2018

HB 57 (Angel) – Large Family Child Care Homes and Child Care Centers – Green Product Cleaning Supplies – Regulations

The bill would require the Board of Education to adopt regulations which would require "to the extent practicable and economically feasible" Large Family Child Care Home facilities to use green cleaning products.

Hearing Date - 01/23/2018

HB 68 (Angel) - Income Tax Credits – Employer Child Care Center and Employer – Provided Child Care Services

The bill would allow self-employed, and non-self-employed individuals to claim a credit against state income tax for the cost of establishing and maintaining a child care facility for its employees. MSDE would be required to issue credit certificates to individuals for qualified expenses related to the child care facility.

Hearing Date - 01/17/2018

HB 74 (Grammer) - Education - Career Exploration and Development Activities - Coffee (Java Act)

This is a local Baltimore County bill that would prevent the Executive Branch from regulating or preventing the sale of coffee that is sold in conjunction with a career exploration or development program in a public high school.

Hearing Date - 02/01/2018

HB 76 (Grammer) - Baltimore County Board of Education - Education Transparency Act

This bill would require the Baltimore County Boards of Education to conduct all meeting open to the public, require the taking of minutes, require all action to be taken by voice vote, require action items to be posted on the county website within 12 hours of action, and to including a full description of the action taken and a video recording of the meeting. Closed meetings would be allowed only when the item to be discussed in closed session complied with the Open Meetings Act (§3-305 of the General Provisions Article).

Hearing Date - 02/01/2018

HB 87 (Ebersole) - Baltimore County Board of Education - Nonstudent Members - Compensation

This bill would increase the compensation that nonstudent members of the Baltimore County Board of Education receive from \$100 annually, to \$7,500 annually.

Hearing Date - 02/01/2018

Passed out of House awaiting hearing date in Senate.

HB 103 (Atterbeary) - Education - County Boards of Education - Removal of County Superintendents

This bill would allow Local School Boards to remove Local Superintendents for: immorality; misconduct in office; insubordination; incompetency; or, willful neglect of duty. Currently, only the State Superintendent may remove a Local Superintendent for these reasons. The County Board will need to follow the existing appeal process as the State Superintendent. The Local Superintendent that is removed will be compensated consistent with terms of their contract or for the remainder of their term.

Hearing Date - 02/01/2018

HB 154 (Ebersole) - State Board of Education - Membership - Teachers and Parent

This bill would increase the State School board from 11 to 14 members. Two of the new members would be individuals who are certified teachers, who is elected amongst all teacher of the State. One will be a parent of a student, who is suggested by the Maryland PTA.

Crossfile – SB 739

Hearing Date - 02/01/2018

HB 156 (Mautz) - Talbot County Board of Education - Start Date of Term for Members

This bill moves the beginning of the term of the Talbot County Board of Education from January 1, to December 1, after the election.

Crossfile – SB 171

Hearing Date - 02/01/2018

HB 193 (Dept. of Labor, Licensing, and Regulation) – High School Diploma by Examination – Eligibility Requirements – Exemption

The bill expands eligibility requirements to participate in the GED program to include students that participate in the GED Option Program, administered by MSDE.

Crossfile – SB 43

Hearing Date - 02/13/2018

Voted Favorable by ENC and W&M committees, on the House floor.

HB 197 (Luedtke) – Education – State Reimbursement for County Board Payments for Exams for Eligible Students

The bill would require MSDE to reimburse Local School Boards for the cost of Advanced Placement, industry certification for a career and technology education program, or an International Baccalaureate exam, up to \$300 for students who are eligible for the Maryland Children's Health Program.

Hearing Date - 02/08/2018

HB 221 (Bromwell) - Local Government - School Construction - Permits

The bill would require Counties and Municipalities to expedite the school construction permit process.

Hearing Date - 02/06/2018

Passed out of the House and is awaiting a hearing date in the Senate.

HB 226 (Ebersole) - Public Schools - Sprinkler Systems - Required

The bill would require all public schools to have a sprinkler system. This would require existing schools without a sprinkler system to retrofit the building.

Crossfile – SB 483

Hearing Date - 02/06/2018

HB 228 (Rey) - Child Care Centers - Definition of Child Care

The bill would exempt or exclude certain programs from the State's licensing requirement by changing the definition of what "child care" means. If the proposed bill passed, some programs already licensed may choose to surrender their license. MSDE would then no longer have regulatory authority to conduct criminal background checks or child protective services clearance.

Hearing Date - 02/06/2018

W&M Education Subcommittee has voted the bill UNFavorable. The full committee has not taken the bill up yet.

HB 251 (Kelly) - Education - Family Life and Human Sexuality Curriculum - Boundaries and Consent

The bill would require LEAs to provide age-appropriate instruction of the meaning of "consent" and respect for personal boundaries as part of the Family Life and Human Sexuality curriculum starting in the 2018-2019 school year.

Crossfile – SB 402

Hearing Date - 02/08/2018

Passed out of the House with amendments and is awaiting a hearing date in the Senate.

<u>HB 281 (A. Miller) – Education – Computer Science – Curriculum and Professional Development (Securing the Future: Computer Science Education for All)</u>

The bill would require LEAs to offer computer science courses by the 2021-2022 school year. The courses shall be of high quality and meet or exceed the curriculum standards established by the State Board. The bill also establishes the Maryland Center for Computing Education at UMBC. The Center shall establish a plan to create a long-term pipeline of computer science teachers and to fund, mentor and provide internships for teachers. Finally, the bill provides \$1,000,000 each year in FY 2020 and 2021.

Hearing Date - 02/08/2018

Passed out of the House with amendments and is awaiting a hearing date in the Senate.

HB 285 (Luedtke) – Department of Transportation – Pedestrian and Bicycle Access to Public Schools

The bill would require the Maryland Dept. of Transportation to conduct a study examining pedestrian and bicycle access to public schools throughout the State.

Hearing Date - 02/08/2018

HB 313 (Mautz) – Education – Commemoration – Terrorist Attaches of Sept. 11, 2001

The bill would add the Terrorist Attacks of Sept. 11, 2001 to the days public schools shall devote part of the day to commemorating.

Hearing Date – 02/08/2018

HB 315 (Hixson) – State Dept. of Education – Breakfast and Lunch Programs – Funding (Maryland Cares for Kids Act)

The bill would make the State responsible for paying the students cost of their reduced breakfast and lunch, eliminating the reduced program and putting all eligible students into the free program.

Hearing Date - 02/08/2018

HB 350 (Administration) – Achieving Computer Science Collaborations for Employing Students Statewide (ACCESS) Act of 2018

The bill would require the State Board of Education to develop and adopt standards for Computer Science Education for kindergarten through grade 12 by November 30, 2018. In the 2020-2021 school year every High School shall offer at least one computer science course. Starting in 2022-2023 every Middle School shall offer computer science education and Elementary School shall offer computational thinking curriculum. The bill also establishes the Maryland Center for Computing Education, within the University System of Maryland. The Center will provide professional development in computer science education to teachers, administrators, and other professionals and increase the gender, racial, disability status, socioeconomic, and geographic diversity of students pursuing computer science careers.

Crossfile - SB 300

Hearing Date - 02/15/2018

HB 351 (Administration) - Protect Our Students Act of 2018

The bill would increase the combined total score of the academic indicators from 60% to 85% for the educational accountability program. Additionally, the bill would require at least one question regarding educators' receipt of critical instructional feedback and access to or credit for completion of a well-rounded curriculum of on-track progress at key transition points within elementary and secondary education.

Crossfile - SB 301

Hearing Date - 03/01/2018

HB 355 (Administration) - Accountability in Education Act of 2018

The bill establishes the Investigator General of the Education Monitoring Unit, which shall; investigate and determine whether the Civil Rights of teachers, students and parents are being upheld in compliance with Federal, State and Local laws and regulations; analyze and report on matters including child abuse, neglect, safety, grading, graduation requirements, assessments, educational facilities, procurement, equitable use of resources among public schools, and budgets; report all instances of fraud, abuse, and waste relating to public funds and property; report employee violations of applicable laws, regulations, policies, or ethical standards of conduct; establish its goals and priorities based on periodic assessment of existing and emerging risks relating to public elementary secondary education in the State, and; employ staff and engage attorneys, advisors, and consultants in accordance with the State budget.

Crossfile - SB 302

Hearing Date - 03/01/2018

HB 366 (Vogt) – Education – PARCC Testing – Children with Disabilities (Ben's Rule)

The bill would allow parents or guardians of children with a disability who is nonverbal may refuse to allow the child to participate in PARCC assessment.

Hearing Date - 02/08/2018

HB 378 (Vogt) - State Dept. of Education - Social Security Numbers of Students

The bill would prevent MSDE from collecting, holding, or storing the Social Security Number of any current, former or prospective student.

Hearing Date - 02/08/2018

HB 393 (Walker) – Elementary School Students – Daily Physical Activity (Student Health and Fitness Act)

The bill would require LEAs to provide a daily program of physical activity totaling 150 minutes each week.

Hearing Date - 02/08/2018

HB 427 (Young) - Public Schools - Student Sunscreen Use - Policy

The bill would prevent LEAs from developing policies preventing students from using sunscreen. It also would require schools to develop policies for how and when school personnel can assist students with applying sunscreen.

Crossfile – SB 217

Hearing Date - 02/08/2018

Passed out of the House with amendments and is awaiting a hearing date in the Senate.

HB 430 (Jones) - Education - Child Care Subsidies - Mandatory Funding Levels

The bill would require the Governor to appropriate enough funds to raise the child care reimbursement rate to the 30^{th} percentile in 2020, 45^{th} percentile in 2021, and 60^{th} percentile in 2022.

Crossfile – SB 379

Hearing Date - 02/13/2018

HB 503 (Wilkins) - State Dept. of Education - Translation Grant Program - Established

The bill creates a grant program for LEAs that have significant requests to translate educational materials into a student's or parent's native language.

Hearing Date - 02/15/2018

HB 544 (Robinson) - Public and Nonpublic Schools - Classwork and Assessment Involving Live and Dead Animals - Student Choice Policy

The bill would require the State Board by September 1, 2018 to develop and implement a student choice policy for students who choose not to participate in or observe classwork or an assessment that includes dissection, vivisection, incubation, infliction of harm, capture, or destruction of an animal.

Crossfile - SB 369

Hearing Date - 02/15/2018

HB 547 (Barron) - Education - Head Start Program - Annual Appropriation

The bill requires the Governor to appropriate at least \$3,000,000 for the Head Start Program annually.

Crossfile – SB 373

Hearing Date - 02/08/2018

Bill has been withdrawn by the sponsor.

HB 553 (Chang) - County Boards of Education - Length of School Year - Adjustments

The bill would allow Local School Boards to extend the school year up to five days without approval from the State Board of Education.

Hearing Date - 02/15/2018

HB 557 (M. Washington) - Primary and Secondary Education - Education Trust Fund - Use of Fund

The bill would require the Governor to appropriate the Education Trust Fund to the LEAs based off the percent of Direct Education Aide that a LEA receives. The Education Trust Fund revenue may not be used to supplement the funds required by formula funds, it is meant to be in addition to the required funding.

Hearing Date - 03/08/2018

HB 568 (Kaiser) - Education - Student Data Governance

The bill would require the MSDE to: develop and update practices for LEAs to manage and maintain data privacy and security for student data and personally identifiable information; develop best practices for professional development on data governance policies and procedures, and; develop strategies to coordinate and assist LEA staff to implement best practices. MSDE is also required to provide a report about the implementation of the bill to the General Assembly on July 1, 2019 and July 1, 2020.

Hearing Date - 02/22/2018

Passed out of the House with amendments and is awaiting a hearing in the Senate.

HB 617 (Ebersole) - Education - Assessments - Administration by Public School Employees

The bill would allow a Principal to select a school employee to administer an assessment.

Hearing Date - 02/15/2017

The bill has been voted FAVorable with amendments by the W&M committee

HB 622 (Patterson) – Public and Nonpublic Schools – Student Sickle Cell Disease Management Programs

This bill requires MSDE and the Maryland Department of Health, along with stakeholders, to develop guidelines for local school system employees to use in the management of student's sickle cell disease during the school day and while attending school-sponsored activities.

Crossfile - SB 161

Hearing Date - 02/15/2018

Passed out of the House with amendments and is awaiting a hearing in the Senate.

HB 643 (Jones) – State Department of Education – Employment Categories and Practices

The bill alters the employment categories of "professional assistants" within MSDE. Most special appointment positions within MSDE, except those who perform a significant policy role or provide direct support to a member of the executive service, would be reclassified to positions in the executive, management, professional, or skilled service under the State Personnel Management System (SPMS), by January 1, 2019.

Hearing Date – 02/13/2018

<u>HB 677 (Pena-Melnyk) – Public Information Act – Required Denials – Physical Addresses, E-Mail Addresses, and Telephone Numbers</u>

The bill would require the denial of physical addresses, email addresses and phone numbers when requested as part of a Public Information Act request.

Crossfile – SB 477

Hearing Date - 02/21/2018

HB 679 (Pena-Melnyk) - Public Schools - School Year - Completion Date

The bill would establish that the third Friday in June is the last day of the school year.

Hearing Date - 02/22/2018

Passed out of the House with amendments and is awaiting a hearing date in the Senate.

HB 723 (Ebersole) – Education – Partnership for Assessment of Readiness for College and Careers (PARCC) Assessment – Administration

The bill would require MSDE as part of the renewal of the contract for administration of the PARCC assessment to require each segment of the assessment be administered within 40-minute time periods.

Hearing Date - 02/22/2018

Bill has been withdrawn by the sponsor.

HB 760 (Impallaria) - Handguns - School Employees - Handgun Permits and Carrying Weapons on School Property

Would authorize Local Boards to enable school personnel to carry a handgun on school property if they meet certain criteria for carrying the weapon.

Hearing Date - 03/06/2018

HB 823 (Luedtke) - Education - Public School Teachers - Preparation

The bill would require LEAs to participate in the Teacher Academy of Maryland (TAM) Program and MSDE to develop a digital recruitment platform to encourage individuals to enter the teaching profession. Additionally, the Maryland Longitudinal Data Center is required to create a dashboard to track and monitor the TAM program.

Hearing Date - 02/22/2018

Passed the House with amendment and is awaiting a hearing in the Senate.

HB 910 (Luedtke) – Education – Students With Reading Difficulties – Screenings and Interventions

The bill requires LEAs to ensure that certain students are screened to identify if the student is at risk for reading difficulties beginning in the 2019-2020 school year. MSDE will need to work with LEAs to identify the appropriate screening tools to identify students.

Crossfile – SB 548

Hearing Date - 02/22/2018

HB 921 (Walker) - State Board of Education - Financial Literacy Curriculum - Graduation Requirement

The bill would require the State Board to develop curriculum content for a semester-long course in financial literacy, which is a graduation requirement. LEAs would be required to implement the curriculum content.

Hearing Date - 03/02/2018

The bill would require LEAs to award high school elective credit to a high school student if the student successfully completes any college course from an institution of postsecondary education, unless MSDE has determined that the college course does not meet a specific high school graduation requirement.

Crossfile – SB 479

Hearing Date - 03/01/2018

HB 968 (B. Barnes) - Maryland School Overcrowding Reduction Act of 2018

The bill alternative financing of school buildings. First, the bill would extend to Counties the ability to hold title of property used for school purposes. Currently a private entity and a local school board have this ability. The bill would also allow a County or private entity to "lease" the property to the school district if the County or private entity "operates and maintains the property." Second, the bill would remove the regulatory authority of the Board of Public works to promulgate regulations for alternatively financed projects and instead places requirements in statute. Finally, a new incentive program would be created to encourage lower cost school facility construction costs.

Crossfile – SB 92

Hearing Date - 02/15/2018

<u>HB 999 (Haynes) – Baltimore City – Chief Executive Officer of the Baltimore City Board of School Commissioners</u> <u>– Title Change</u>

The bill would change the title of the Baltimore City Chief Executive Officer to Superintendent.

Hearing Date - 02/23/2018

HB 1098 (Korman) - Career and Technology Education and Workforce Investment Act

The bill creates a grant program to provide capital funds to equip school facilities used to provide Career and Technology Education program (CTE) and will be administered by the Interagency Committee on School Construction.

Crossfile – SB 515

Hearing Date – N/A

HB 1154 (Gutierrez) - Teachers and Teacher Preparation Bilingual Certification and Instruction

The bill would require the State Board and the Professional Standards and Teacher Education Board to create a certification program for bilingual teachers by July 1, 2019.

Hearing Date - 02/23/2018

HB 1210 (Hill) - Education - Public Schools and Youth Sports Programs - Physical Sports

The bill would change the term "concussion" to "head injury" and enhance the program that MSDE is required to develop to address awareness of head injuries. Additionally, it would prohibit the Board and youth sport associations to sanction "physical sports" which is defined as: tackle football; soccer in which head butting is allowed; ice hockey, field hockey and lacrosse, in which checking is allowed; tackle rugby, and; any other sport with a high risk of head injury.

Hearing Date - 03/02/2018

Bill has been voted UNFavorable by the W&M committee.

HB 1234 (Clippinger) - Career Youth Apprenticeship and Apprenticeship in State Employment Opportunity Act

The bill would require the State Board to require LEAs to award high school graduation credit for participation in apprenticeship programs and create apprenticeship program in needed job classifications within the State of Maryland workforce.

Crossfile – SB 614

Hearing Date - 03/08/2018

HB 1373 (Miele) - Education - Assessments - Administration

The bill would prohibit administration of the PARCC assessment and require the use of the California Achievement Test (CAT) beginning in the 2018-2019 SY.

Hearing Date - 03/09/2018

HB 1415 (Speaker) - Education Commission on Innovation and Excellence in Education

The bill comes out of work that has been accomplished by the Kirwin Commission. There are a number of initiatives covered under in this bill including: a teaching outreach program designed to encourage top performing students to become a teacher; implement an initiative to address early literacy; continues the funding of the pre-k expansion grant; continues the funding of the Public Schools Opportunities Enhancement Grant program; support and funding to provide extended academic programs; provide funding to the "teaching fellows of Maryland" program; provide funding to expand CTE; extend the term of the Kirwin Commission; and, modify a RFP to look at the IEP process to learn how look at how "top-performing" school systems address education for students with disabilities.

Crossfile – SB 1092

Hearing Date - 03/07/2018

HB 1446 (Long) – Public Schools – School Emergency Response Systems – Study (Safer Schools Act)

The bill requires the Maryland Center for School Safety to study the best practices and procedures regarding emergency response systems in elementary and secondary school systems.

Hearing Date - 03/09/2018

HB 1545 (Waldstreicher) - State Board of Education - Nutrition Standards for Public School Food

The bill would require the State Board to establish minimum nutrition standards for food provided or sold in public schools to meet standards more stringent than federal guidelines.

Hearing Date - 03/02/2018

HB 1565 (McCray) - Nonpublic Elementary and Secondary Schools - Discrimination - Prohibition

The bill would prohibit non-public schools that receive state funds from discriminating against any student based on race, color, religion (unless it is a religiously affiliated institution), sex (unless the school is a single-gendered school since its inception), age, national origin, marital status, sexual orientation, gender identify, or disability.

Crossfile - SB 1060

Hearing Date - 03/01/2018

HB 1607 (Luedtke) - Education - Juvenile Services Education Programs - Management and Operation

The bill would establish a pilot program to have a local school system operate a juvenile services education facility within their county.

Hearing date - 03/01/2018

HB 1783 (Jones) – 21st Century School Facilities Act

The bill would modify the school maintenance and school construction funding process. The bill is the result of the "Knott" commission.

Crossfile – SB 1243

Hearing Date - 03/08/2018

HB 1811 (Fraser-Hidalgo) - Education - Threat Assessment Teams - Establishment and Oversight

The bill would require the MSDE to develop a threat assessment team model policy by January 1, 2019, and would require LEAs to have threat assessment team by the 2019-2020 SY.

Hearing Date – N/A

HB 1815 (Speaker) - Commitment to Education Act of 2018

The bill would require the money in the Education Trust Fund to be expended to support the School Safety Fund, funding public elementary and secondary education, and PAYGO construction funding.

Crossfile – SB 1258

Hearing Date – N/A

HB 1816 (Speaker) – Safe Schools Act of 2018

The bill would require LEAs to: employ a designate security administrator; prepare a school emergency plan for each school in the county; establish a school threat assessment team; and establish a fund to provide assistance with implementation of the bill requirements.

Crossfile – SB 1257

Hearing Date – N/A

<u>Senate</u>

SB 29 (Kagan) - State Government - Websites - Language Access

The bill would require state agencies, including MSDE, to provide access to versions of their website in languages spoken by 0.5% of the State population as identified by the census if the translation can be translated free of charge.

Hearing Date - 01/24/2018

Passed out of the Senate and has a hearing in the House on 03/21/2018.

<u>SB 31 (Bates) – State Retirement and Pensions System – State Employees and Teachers – Benefits</u>

The bill would modify the State Employees and Teachers State Retirement and Pension Plan for current and new employees to create a defined benefit plan, reduced from current amounts, and a defined contribution savings plan. The State's contribution to these plans would be lower than the current amount.

Hearing Date- 01/25/2018

<u>SB 43 (Dept. of Labor, Licensing and Regulation) – High School Diploma by Examination – Eligibility</u> <u>Requirements – Exemption</u>

The bill expands eligibility requirements to participate in the GED program to include students that participate in the GED Option Program, administered by MSDE.

Crossfile – HB 193

Hearing Date - 01/16/2018

Passed out of the Senate and is scheduled for a hearing in the House on 03/22/2018.

<u>SB 44 (Young) – Vehicle Laws – School Buses – Inspection, Repair, and Maintenance Requirements</u>

The bill requires the owner of a school bus to ensure that the vehicle is inspected, repaired and maintained in accordance with federal safety regulations, prohibits the operation of the vehicle unless it has been inspected, and enables the MVA to suspend the registration of a non-compliant vehicle.

Hearing Date - 01/17/2018

The bill has been withdrawn by the sponsor.

SB 58 (Dept. of Health) – State Board for Certification of Residential Child Care Program Professionals – Revisions

The bill removes a provision granting immunity from liability for participating in activities of the State Board of Certification of Residential Child Care Program Professionals, requires, except under certain circumstances, that an applicant successfully complete an approved training program, and removes a provision that requires the publication of approved training programs on the Boards website.

Hearing Date - 01/18/2018

<u>SB 92 (Rosapepe) – Maryland School Overcrowding Reduction Act of 2018</u>

SB 92 pertains to alternative financing of school buildings. First, the bill would extend to Counties the ability to hold title of property used for school purposes. Currently a private entity and a local school board have this ability. The bill would also allow a County or private entity to "lease" the property to the school district if the County or private entity "operates and maintains the property." Second, the bill would remove the regulatory authority of the Board of Public works to promulgate regulations for alternatively financed projects and instead places requirements in statute. Finally, a new incentive program would be created to encourage lower cost school facility construction costs.

Crossfile – HB 968

Hearing Date - 01/31/2018

SB 103 (Benson) - Task Force to Study the Impact of Student Cell Phone Use in the Classroom

The bill would create a task force to study the impact of student cell phone use in the classroom on student learning teacher instruction, benefits associated with cell phone use in the classroom, and any other related matters determined by the task force. MSDE would be required to provide staff.

Hearing Date – 01/17/2017

SB 131 (Zirkin) - Child Abuse and Neglect - Training

This bill will require health practitioners, police officers, educators, and human service workers to be periodically trained in compliance with §5-704 of the Family Law Article and on identifying abused and neglected children.

Hearing Date - 01/23/2018

SB 132 (Zirkin) - Crimes - Child Abuse and Neglect - Failure to Report

This bill would subject a person who knowingly does not report child abuse or neglect as under §5-704 of the Family Law Article will be guilty of a misdemeanor and subject to a penalty of \$1,000, six month in jail, or both.

Hearing Date - 01/23/2018

Passed out of the Senate with amendments and is awaiting a hearing in the Senate.

SB 161 (Nathan-Pulliam) - Public and Nonpublic Schools - Student Sickle Cell Disease Management Programs

This bill requires MSDE and the Maryland Department of Health, along with stakeholders, to develop guidelines for local school system employees to use in the management of student's sickle cell disease during the school day and while attending school-sponsored activities.

Hearing Date - 01/24/2018

Passed out of the Senate with amendments and has a hearing in the House on 03/22/2018.

SB 164 (Nathan-Pulliam) - Education - Student Use of Backpacks - Assessment and Reduction of Health Effects

This bill would require Local School Boards to provide all school personnel, parents, and students with information about potential impact of heavy backpacks and measures that can be taken to prevent those impacts. It also requires the Boards to allow Chiropractors to conduct scoliosis exams, as often as the Board deems necessary.

Hearing Date - 01/24/2018

Voted UNFavorable by the EHEA committee.

SB 171 (Eckardt) - Talbot County Board of Education - Start Date of Term for Members

This bill moves the beginning of the term of the Talbot County Board of Education from January 1, to December 1, after the election.

Hearing Date - 01/24/2018

Passed out of the Senate and has a House hearing on 03/22/2018.

<u>SB 205 (Rosapepe) – High School Credit Clarification Act of 2018</u>

The bill would require LEAs to aware High School Credit to a middle school student for a course, where a high school student would receive credit, or MSDE has approved for the award of High School Credit under §7-1002 of the Education Article, which pertains to virtual learning.

Hearing Date - 01/31/2018

<u>SB 217 (Young) – Public Schools – Student Sunscreen Use – Policy</u>

The bill would prevent LEAs from developing policies preventing students from using sunscreen. It also would require schools to develop policies for how and when school personnel can assist students with applying sunscreen.

Crossfile - HB 427

Hearing Date - 02/08/2018

<u>SB 236 (Robinson) – State Board of Education – Financial Literacy and Entrepreneurship Curriculum – Development and Implementation</u>

The bill would require the State Board to develop curriculum for a semester-long High School elective course in financial literacy and entrepreneurship. LEAs would not be required to implement the financial literacy and entrepreneurship course, as the bill is permissive in its requirement for LEAs.

Hearing Date - 01/31/2018

<u>SB 300 (Administration) – Achieving Computer Science Collaborations for Employing Students Statewide</u> (ACCESS) Act of 2018

The bill would require the State Board of Education to develop and adopt standards for Computer Science Education for kindergarten through grade 12 by November 30, 2018. In the 2020-2021 school year every High School shall offer at least one computer science course. Starting in 2022-2023 every Middle School shall offer computer science education and Elementary School shall offer computational thinking curriculum. The bill also establishes the

Maryland Center for Computing Education, within the University System of Maryland. The Center will provide professional development in computer science education to teachers, administrators, and other professionals and increase the gender, racial, disability status, socioeconomic, and geographic diversity of students pursuing computer science careers.

Crossfile - HB 350

Hearing Date - 02/07/2018

SB 301 (Administration) - Protect Our Students Act of 2018

The bill would increase the combined total score of the academic indicators from 60% to 85% for the educational accountability program. Additionally, the bill would require at least one question regarding educators' receipt of critical instructional feedback and access to or credit for completion of a well-rounded curriculum of on-track progress at key transition points within elementary and secondary education.

Crossfile – HB 351

Hearing Date - 02/07/2018

Voted UNFavorable by EHEA.

SB 302 (Administration) - Accountability in Education Act of 2018

The bill establishes the Investigator General of the Education Monitoring Unit, which shall; investigate and determine whether the Civil Rights of teachers, students and parents are being upheld in compliance with Federal, State and Local laws and regulations; analyze and report on matters including child abuse, neglect, safety, grading, graduation requirements, assessments, educational facilities, procurement, equitable use of resources among public schools, and budgets; report all instances of fraud, abuse, and waste relating to public funds and property; report employee violations of applicable laws, regulations, policies, or ethical standards of conduct; establish its goals and priorities based on periodic assessment of existing and emerging risks relating to public elementary secondary education in the State, and; employ staff and engage attorneys, advisors, and consultants in accordance with the State budget.

Crossfile – HB 355

Hearing Date - 02/07/2018

<u>SB 326 (Ferguson) – Education – Public School Opportunities Enhancement Program – Administration Resources</u>

The bill would require MSDE to hire a person to administer the program and allow a portion of the appropriation to be used to fund the position.

Hearing Date - 02/07/2018

Withdrawn by the sponsor.

<u>SB 369 (Young) – Public and Nonpublic Schools – Classwork and Assessment Involving Live and Dead Animals –</u> <u>Student Choice Policy</u>

The bill would require the State Board by September 1, 2018 to develop and implement a student choice policy for students who choose not to participate in or observe classwork or an assessment that includes dissection, vivisection, incubation, infliction of harm, capture, or destruction of an animal.

Crossfile - HB 544

Hearing Date - 02/07/2018

Voted UNFavorable by the EHEA committee.

SB 373 (Currie) - Education - Head Start Program - Annual Appropriation

The bill requires the Governor to appropriate at least \$3,000,000 for the Head Start Program annually.

Crossfile – HB 547

Hearing Date - 02/07/2018

Passed out of the Senate with amendments and is awaiting a hearing in the House.

SB 379 (King) – Education – Child Care Subsidies – Mandatory Funding Levels

The bill would require the Governor to appropriate enough funds to raise the child care reimbursement rate to the 30th percentile in 2020, 45th percentile in 2021, and 60th percentile in 2022.

Crossfile – HB 430

Hearing Date - 02/14/2018

SB 402 (Zucker) - Education - Family Life and Human Sexuality Curriculum - Boundaries and Consent

The bill would require LEAs to provide age-appropriate instruction of the meaning of "consent" and respect for personal boundaries as part of the Family Life and Human Sexuality curriculum starting in the 2018-2019 school year.

Crossfile – HB 251

Hearing Date - 02/14/2018

Passed out of the Senate with amendment and has a House hearing on 03/22/2018.

SB 438 (Ramirez) - State Dept. of Education - Nonprofit Youth Development Program - Established

The bill creates the Nonprofit Youth Development Program to provide grants to nonprofit organizations that target at-risk youth. MSDE and the People for Change Coalition, Inc. will develop and administer the program together. Also provides for an annual appropriation of \$1,000,000.

Hearing Date - 02/14/2018

Voted UNFavorable by EHEA committee.

<u>SB 477 (Kagan) – Public Information Act – Required Denials – Physical Addresses, E-Mail Addresses, and Telephone Numbers</u>

The bill would require the denial of physical addresses, email addresses and phone numbers when requested as part of a Public Information Act request.

Crossfile – HB 677

Hearing Date - 02/14/2018

Passed the Senate and has a hearing in the House on 03/21/2018.

SB 479 (Rosapepe) – High School Credit for College Courses Act of 2018

The bill would require LEAs to award high school elective credit to a high school student if the student successfully completes any college course from an institution of postsecondary education, unless MSDE has determined that the college course does not meet a specific high school graduation requirement.

Crossfile – HB940

Hearing Date - 02/14/2018

Voted UNFavorable by EHEA committee.

SB 515 (Currie) – Career and Technology Education and Workforce Investment Act

The bill creates a grant program to provide capital funds to equip school facilities used to provide Career and Technology Education program (CTE) and will be administered by the Interagency Committee on School Construction.

Crossfile – HB 1098

Hearing Date - 02/21/2018

Passed the Senate with amendment and awaiting a hearing date in the House.

The bill requires LEAs to ensure that certain students are screened to identify if the student is at risk for reading difficulties beginning in the 2019-2020 school year. MSDE will need to work with LEAs to identify the appropriate screening tools to identify students.

Crossfile – HB 910

Hearing Date - 02/21/2018

SB 618 (Klausmeier) - Career Youth and Public Sector Apprenticeship Act

The bill would require the State Board to require LEAs to award high school graduation credit for participation in apprenticeship programs and create apprenticeship program in needed job classifications within the State of Maryland workforce.

Crossfile – HB 1234

Hearing Date - 02/28/2018

SB 678 (Benson) - State Department of Education - Employment Categories and Practices

The bill alters the employment categories of "professional assistants" within MSDE. Most special appointment positions within MSDE, except those who perform a significant policy role or provide direct support to a member of the executive service, would be reclassified to positions in the executive, management, professional, or skilled service under the State Personnel Management System (SPMS), by January 1, 2019.

Hearing Date - 02/20/2018

SB 739 (Madaleno) - State Board of Education - Membership - Teachers and Parent

This bill would increase the State School board from 11 to 14 members. Two of the new members would be individuals who are certified teachers, who is elected amongst all teacher of the State. One will be a parent of a student, who is suggested by the Maryland PTA.

Hearing Date - 02/28/2018

SB 1060 (Kagan) - Nonpublic Elementary and Secondary Schools - Discrimination - Prohibition

This bill would prohibit non-public schools that receive state funds from discriminating against any student based on race, color, religion (unless it is a religiously affiliated institution), sex (unless the school is a single-gendered school since its inception), age, national origin, marital status, sexual orientation, gender identify, or disability.

Hearing Date - 02/21/2018

SB 1092 (President) - Education - Commission on Innovation and Excellence in Education

The bill comes out of work that has been accomplished by the Kirwin Commission. There are a number of initiatives covered under in this bill including: a teaching outreach program designed to encourage top performing students to become a teacher; implement an initiative to address early literacy; continues the funding of the pre-k expansion grant; continues the funding of the Public Schools Opportunities Enhancement Grant program; support and funding to provide extended academic programs; provide funding to the "teaching fellows of Maryland" program; provide funding to expand CTE; extend the term of the Kirwin Commission; and, modify a RFP to look at the IEP process to learn how look at how "top-performing" school systems address education for students with disabilities.

Hearing Date - 03/07/2018

<u>SB 1243 (DeGrange) – 21st Century School Facilities Act</u>

The bill would modify the school maintenance and school construction funding process. The bill is the result of the "Knott" commission.

Crossfile – HB 1783

Hearing Date – N/A

SB 1257 (President) - Safe School Act of 2018

The bill would require LEAs to: employ a designate security administrator; prepare a school emergency plan for each school in the county; establish a school threat assessment team; and establish a fund to provide assistance with implementation of the bill requirements.

SB 1258 (President) - Commitment to Education Act of 2018

The bill would require the money in the Education Trust Fund to be expended to support the School Safety Fund, funding public elementary and secondary education, and PAYGO construction funding.
