




Top 5 Languages Spoken by Maryland English Learners

Grade Span of English Learners







% of Students Eligible for Free and Reduced Priced Meals by EL Status



% of Students with Disabilities by EL Status


% Gifted and Talented Students by EL Status



Where are English learners concentrated in Maryland?




Percent of English learner population in local school systems 2020-2021 Enrollment



How are ELs identified and placed into English language delivery (ELD) services?

Upon enrollment each family completes a Home Language Survey (HLS). If a language other than English is indicated on the HLS, the student is screened for ELD services. Potential ELs are screened: <u>Grade 1-12</u> WIDA Screener <u>Kindergarten</u> WIDA Screener (for K) or

K-W-APT.

Parents are notified and may accept or refuse ELD services. WIDA scores are used to assist with class/course placement.

What is Maryland's exit procedure?

ELs, including students whose parents refused English language development (ELD) services, are assessed annually to measure English language proficiency.

The annual scores of ACCESS for ELLs or Alternate ACCESS for ELLs are used to make exit and course decisions.

Parents are notified of the exit from ELD services. Reclassified English learners (RELs) are monitored for two years after exiting from ELD services.

RELs can resume ELD services based on academic performance.

*English learners with significant cognitive disabilities take an alternate English language proficiency test and exit when they have achieved an overall proficiency level of P2.





Maryland's EL Exit Rate






For example, if an English learner has an initial year proficiency level between a 3.0 and a 3.9, their target for their second year assessment result is 3.7, 4.2 in their third year, and 4.5 in their fourth year. A level of 4.5 or higher means the student has met Maryland's exit target.





How do English learners and recently reclassified* perform on high school state assessments?




Percent Proficient English 10










← 4-year cohort grad rate ← 5-year cohort grad rate
