## **Discussion/Action Items**

#### COMAR 13A.12.01 Update

Dr. Joann Ericson stated that the purpose of this item is to present additional changes to COMAR 13A.12.01, General Provisions, for discussion and to request permission to publish the proposed changes. Ms. Jean Satterfield explained that when the proposed changes to COMAR 13A.12.01, General Provisions, were initially published, a portion of the proposed changes was omitted. Public comment provided some feedback with which staff agreed; other changes based on feedback after the initial publication is also being proposed.

The following changes were proposed to COMAR 13A.12.01:

**Page 4** – Job embedded professional learning – added "and approved by the local school system superintendent".

Page 7 - C 2 & 3 - added the word "Middle".

- **Page 7** Personnel Not Eligible added the following statements.
  - (i) If the Department's investigation concludes that the individual has committed a cause listed under COMAR 12A.12.05, that individual shall be denied a credential by the Department.
  - (ii) An individual who has been denied a credential may appeal that decision through the process outlined in COMAR 12A.12.05.
- Page 8 (iii) The period of denial shall be determined by the State Superintendent of Schools. An individual may again seek credentialing once the period of denial has expired.
- Page 10 (3a) Submit added "when testing requirements change, the previously accepted tests will remain valid for 3 years from the date of adoption of the new test requirements.
- Page 11 Exceptions inserted the following language: See attached
- Page 12 Initial Professional Certificate inserted the following language in: (1b) "for the first time in the State"
- Page 21 See attached
- Page 22 (7A) added the following language "Professionally Credentialed."
- Page 24 See attached

Page 26 - (D) added the following language – "To add a Professional and Technical area, the degreed teacher must submit an industry-recognized credential, a list of which is maintained by the Certification Branch."

After discussion, Mr. Hornbeck presented two options to the PSTEB: Approve the proposed additional changes now or take the information back to the groups they represent for their approval.

#### EARLY CHILDHOOD TASK FORCE REPORT

Ms. Jean Satterfield introduced Dr. Rolf Grafwallner, Assistant Superintendent for the Division of Early Childhood. Dr. Grafwallner reviewed the results of the Task Force for Early Childhood Education and shared the final report with the PSTEB members.

Dr. Grafwallner stated that one of the recommendations from the workgroup was to develop skilled educators for children from birth to third grade who would be would be dually certified in early childhood and special education. This would also necessitate a grade band change for early childhood from the current PreK-grade 3 to Infant-grade 3.

Dr. Grafwallner asked for permission to convene a workgroup to look at a "Teacher Preparation Program for Early Childhood Teachers." Dr. Grafwallner and Ms. Jean Satterfield will co-chair the workgroup. Representative stakeholders on the workgroup will include teachers, directors of human resources, higher education, and MSDE special education staff.

Ms. Louise DeJesu expressed her concern for students in regards to the sizes of the classes when a child with an IEP goes from a class of four to a class of twenty-three (23). Ms. DeJesu commented that dual certification would help with this situation. Charles County has dual setting in place at most of their schools. Blended curriculum would also be very helpful in the PreK setting.

Mr. Darren Hornbeck discussed with the PSTEB permission needed to convene a workgroup on dual certification for early childhood teachers.
