**Legislative Update**

Ms. Tiffany Clark presented a summary of the Maryland General Assembly 2019 Session on Senate Bill 1030 (House Bill 1413) to the PSTEB. This bill establishes The Blueprint for Maryland's Future as State education policy, based on the recommendations of the Commission on Innovation and Excellence in Education (Kirwan Commission). Ms. Clark stated that Senate Bill 1030 passed 43 to 1. House Bill 1413 was floor favorable with amendments. This regulatory language is aligned to the MSDE comprehensive plan to increase the rigor and accountability of educator certification and teacher preparation programs in Maryland.

The regulatory language provided for discussion establishes the program requirements for educator preparation programs leading to initial Maryland teacher certification.

**Transforming Certification: Teacher Licensure (For Discussion and Approval) (Attachment IV)**

Ms. Sarah Spross provided an updated presentation on Transforming Certification: Teacher Licensure.

**PURPOSE:**

The purpose of this item is to provide information to the PSTEB members for discussion and ultimately, determination of which licenses, formerly referred as certificate types, will be available to Maryland educators. Once again, assuring that the proposed licenses are aligned to the MSDE comprehensive plan to increase the rigor and accountability of educator certification and teacher preparation programs in Maryland.

**EXECUTIVE SUMMARY:**

This item provides the necessary information for the PSTEB members to engage in a discussion and ultimately, make decisions about what will be the future licenses available to Maryland educators. The presentation provides specific decision points that will assist the MSDE staff in developing policy and/or regulations related to the certification action plan. The action plan includes items identified by the MSDE, the State Board of Education, the PSTEB, and

recommendations of the Commission on Innovation and Excellence in Education and the Teacher Induction, Retention, and Advancement Act of 2016 Workgroup.

**DISCUSSION:**

Ms. Spross outlined the changes that will be made to move away from the current eight (8) licenses down to five (5) licenses.

The new licenses are:

- Conditional: 5 year validity – No renewable.
- Temporary Professional: 2 year validity – Not renewable.
- Initial Professional: 5 year validity – Is renewable.
- Professional: 5 year validity – Is renewable.
- Adjunct: 1 year validity – Is renewable.

The PSTEB members asked very in-depth questions and expressed their concerns in regards to the changes to the licenses. Ms. Spross answered all the questions and concerns that were asked by the PSTEB members. Ms. Maleeta Kitchen stated that she would like to take the information back to the organization that she represents to get their input. Ms. Spross agreed with this suggested and recommended that each member speak with the organization that they represent. Further discussion on the teacher licenses will continue at the May meeting.
