Introduction

In January 2014, the State Board of Education adopted regulations guiding student discipline. The regulations were designed to keep students in school maintaining progress toward graduation while strengthening school safety. Beginning in the 2015-2016 school year, the Code of Maryland Regulations (COMAR) 13A.08.01.12 - Arrests on School Premises requires local education agencies (LEAs) to report data on school arrests and referrals to law enforcement agencies or the Department of Juvenile Services (DJS) annually.

This report contains data on the number of student arrests in each LEA during the 2021-2022 school year. The data includes arrests that occurred as a result of a referral of a student by school personnel to law enforcement or DJS for a disciplinary offense that occurred on school grounds or during off campus activities, including transportation. This report includes both physical and paper arrests. A physical arrest occurs when a student is physically placed under arrest by a law enforcement official. A paper arrest occurs when there is an officer-initiated referral or request for charges by school officials to DJS (e.g., Juvenile Offense Report, Citation for Court Appearance).

Note: In instances where the number of students in a cell was less than 10, the data were removed and replaced with an asterisk to protect student identity.
