Program Description

The Nonpublic School Health and Security program provides funds for school nurses, other health services, and for school security for nonpublic schools that participated in the BOOST Scholarship Program in fiscal year 2023. By providing necessary resources and support, the NSHS Program provides funds to ensure schools can deliver quality education while prioritizing the health and safety of their students.

The importance of school health professionals and security measures in nonpublic schools is recognized as essential for maintaining a healthy and safe learning environment. School nurses provide immediate medical attention, medication administration, and response to health emergencies, ensuring the overall well-being of students. Likewise, other health professionals such as mental health professionals also play an important role in fostering a supportive school environment conducive to learning and personal growth. The safety of schools is supported by the NSHS Program through security measures such as surveillance systems, alarm systems, and/or the presence of trained security personnel.

To provide funds to nonpublic schools for school nurses, other health services, and for school security.

Grant Period

July 1, 2023 - June 30, 2024

Funding Amount Available

\$2,500,000

If funds remain after awarding the NSHS grants, the remaining funds will be used to augment fiscal 2024 Nonpublic School Textbook Program school allocations. Funds not expended for this added purpose may not be transferred by budget amendment or otherwise to any other purpose and shall be canceled.

Award Amount

Award amounts will be calculated in the following manner:

- Base award for every eligible school: \$7,400
- The remaining funds will be equally disbursed among all eligible schools, based on the total student enrollment they reported in their fiscal year 2022 application to the Nonpublic Textbook Program

Eligibility

The program is limited to the 171 nonpublic schools that participated in the BOOST Scholarship Program during fiscal year 2023.

Use of Funds

Funds for the NSHS Program will be disbursed via reimbursement. Therefore, an invoice must be submitted, requesting reimbursement for allowable purchases. The grant program is designed to provide additional support and enhance the capacity of nonpublic schools in ensuring the well-being and safety of their students. Therefore, careful consideration should be given to utilizing NSHS funds in a manner that complements and enhances the existing infrastructure and initiatives aimed at promoting school health and security.

- **Goods:** Schools may request reimbursement for goods purchased that align with the allowable use of funds. When schools submit an invoice to MSDE, it is necessary that receipts are attached to the invoice to evidence expenses. Requests for reimbursement for goods purchased must be submitted no later than October 16, 2023.
- **Services:** Schools may engage in a contract with a nurse, other health professional, or security officer for services that align with the allowable use of funds. If a contract is initiated, it must end no later than June 30, 2024. MSDE will consider submission of a signed contract as sufficient evidence to obligate, or set aside, funds for that school to invoice for throughout the course of fiscal year 2024. The contract must be submitted to MSDE no later than October 16, 2023.

While the grant period is from July 1, 2023 through June 30, 2024, any funds that have not been obligated by October 16, 2023 must be reverted to the Nonpublic Textbook Program.

If funds remain after awarding the NSHS grants, the remaining funds will be used to augment fiscal 2024 Nonpublic School Textbook Program school allocations.
