

## Maryland College and Career Ready Curriculum Framework English Language Arts

In June 2010, the Maryland State Board of Education adopted the Common Core State Standards. These Frameworks are the result of a year-long effort by Maryland educators to unpack the Common Core State Standards and identify the essential skills and knowledge that a student would need in order to master the grade specific standards. Since the Common Core State Standards did not include Pre-K, Maryland educators created standards and developed the essential skills and knowledge to serve these students. The Frameworks are not intended to convey the order in which the standards should be taught nor the length of time to devote to a unit of study.

The Maryland College and Career Ready Curriculum Frameworks in English Language Arts integrate standards from different strands. Throughout the Maryland Essential Skills and Knowledge, references such as See CCSS 6 SL4 (“See Common Core State Standards, Grade 6, Speaking & Listening, Standard 4”) are provided.
