

Maa thilkhamnah le tlangtlaknah kong hngalhternah caa he hringtu nu le paw nawl nuinah kong kha petlai ah a tling tak tak ah nu le paw aa chuarkehnah aa rii ti ah cia caang ka a nek nah ah rii khoi aa cang ah. Maa caa he nawi heh a tlangting lo paw, le aa chung le ta federal upadi cangseh, aa chambawi paw congsaw, pumpah pakhat cawta hman khoi aa cang ah.

Maa fianhnternah caa chung lai aa te paw huhphenhnah kong caa “the federal Individuals with Disabilities Education Act (IDEA)”, 20 U.S.C. §1400 *et seq.*, the Code of Federal Regulations (CFR), 34 C.F.R. § 300.1 *et. seq.* (IEP) and 34 C.F.R. § 303.1 *et. seq.* (IFSP) le a tang lai ta aa te paw Maryland Regulations code aa cia nah chapter, COMAR: COMAR 13A.05.01, COMAR 13A.08.03, and COMAR 13A.13.01 lai tah minn khoi aa cang ah. Mizawpui cawta rian aa hrai paw agency rung ca mah thilkhamnah cawta aa hawi paw IDEA rung kha na minnkhenh aa, na dirh pui aa cin ca naa tlingseh an ci. Aa hiar cang caa cu, maa hnaglhternah caa ta IDEA ii part B ma part C, a cang lawi le IEP cata Part B, IFSP cawta Part C, ta paw rung kha a hiar ning ning aa a ca hmuhsah ka aa ca fianh sek te ah.

IFSP lang ah rianh/services aa ngar paw nawiheh le chungkhar cawta cu aa nu le aa paw ta mhinkhamnah le tlangtlaknah kong kha petlai paw caa, aa khawpi kha kua aa cang ah ka:

Aa mhasa cem nawiheh tuan tii senginn kai khoi nah sapecial fim cawnnah service ngar nah nawl aa pek hlen hai tah public agency lang ah nawiheh tuantii aa senginn kai hlen aa kar lai sapecial fim caannah a kai khoi voi tah nu le paw hnatlaknah aa hoi. Nu le paw lang ah mah a kar lak fim cawnnah nawl duu lawi kaw khoi zawng aa cang. Aa cang na ti ah mah ta khe duu lawi kaw nah a ruang hnatlaknah kong lait ah menkhiahnah aa um te ah.

Nu le paw hnatlaknah ti mi cu:

- Nu le paw aa chuhkehnah rii ah cang seh aa cang paw petlai nah phing aa cang seh tuar vawi paw, tuar aa hiar paw kong lam vialtii aa fiang tii ah aa hnii caa paw aa cang aa;

Public agency ta nawiheh pakhat khat sapecial education ngar khoi nak voi paw ta nu le paw hnatlaknah um lawi ah agency nawl ah mhinn a tlangtling voi tuar pek aa ngah beh: Bialak ta nawiheh aa nu le aa paw tah-

- Aa sawtii cawta special eduation le aa petlai paw services aa duu pah lawi cang ca cu; aa cang lawi le

Aa dongnah ta, nu le paw lang ah aa sawtii le aa cohlan vawi paw sapecial education le aa petlai paw services record rung kha aa duu lawi cu public agency kha hrawk seh thluu aa ngar.

Aa sullam:

Biaceihnah aa caan sinning:

Ni 30 chung biakhiahnah meeting aa dih cang kaw ni 45 aa luan hlen tah ta paw *Adjustments to the 30 Calendar Day Resolution Period*, lai aa cia ning ah biaceihnah aa caan aa iihh khoi ni 45 lai tah:

- Aa dongh nah biakhiahnah chuar pui aa cang ca; le
- A rii paw biakhiahnah ca khat hnih lang khawi pi ah mail ah kua aa cang ah.

ALJ ta cu pakhat khat lang nawl nah ah biaceihnah aa caan kha ni 45 ten sii pui khoi aa cang. Voi khat voi khat aa tuar paw biaceih nah ca nu le paw le aa sawtii le aa siaremhnah lai tah le aa caan lai tah tuar pah aa cang ah.

Aa rang tein dihter mi Due Process biaceihnah (IEP ONLY):

Public agency ta cu biaceihnah aa rang na ah dihh voi paw cawta le biacheih nah lai ti aa cai paw nawiheh aa tlamtling lawi paw heh:

Due process biaceihnah caa aa thuu cang kaw ni 20 chung lai tah tuar aa cang ah. Biaceihnah aa tuar khoi ni 10 chung lai tah ALJ lang ah biakhiahnah aa chuar pui ah. Biakhiahnah kong lam meeting kha ni 7 chung lai tah tuar cang ah ka aa chuak paw aa phi kha khap nihih lang ah aa lung tling vawi tah ni 15 chung lai tah tuar aa sang ah.

Biaceihnah ii Biakhiahnah:

Cawngsaw pakhat cio aa cang nah lang seh lawi tuar khoi cu, mah biaceihnah ti aa chuar puipaw aa dong nah biakhiahnah le aa mhuh nah kha mipui sin lang thuui seh voi ta ca public agency aa tuanvo aa cang.³⁹

Mah kong lam cawlcanghnah rung kha petlai ah IDEA Part B tang lai tah mhuh khoi aa cang ah due process kha aa petlai paw mhai lang kar hlan nah kong kha ca nu le paw le public agency lang ti IDEA part B nah lai tah aa um ah.
