B. State ECAC Update: Mai Hall

1. Mai provided an update of the number of child care centers that are permanently closed around the state (1%) and how that mostly affects family child care centers. She also provided a brief overview of the Building Better Beginnings Pritzker Children's Initiative. And finally, Mai informed the group of the new local ECEC virtual meetings. She reported a full webinar will be made available online of the State ECEC meetings.

- C. SICC Initiatives
  - 1. CRISP Update: Brenda Hussey-Gardner

a) Brenda provided an update on CRISP to the meeting. She reported the spot checks she completed was correct. The CRISP team are reevaluating how they can present CARE Alerts for each stakeholder in the process. And finally, the team is beginning the second phase which may include sending a list of patients who are likely to be eligible for MITP to a provider. This could be helpful in monitoring families who may be eligible and receive services in the program.

2. Enhancing LITP & Pediatrician Communication Update: Brenda Hussey-Gardner

a) Brenda explained that Pediatrician, Interventionists, and Special Educators (PIE) share a piece of the "pie" in supporting young children with developmental delays and their families. She shared the mission, the meeting frequency (1<sup>st</sup> Thursdays of the month), and development of nine goals.

3. Screen Time Project Update: Anna Maria Wilms Floet

a) Anna Maria provided an update on the Screen Time Project. She is working alongside a second-year pediatric resident. They are conducting a literature review with plans to develop an infographic. She asked SICC attendees to send data/resources to support their work.

4. Infant Mental Health Task Force Update: Cyndi Lessner

a) Based on group feedback, will plan to reconvene to discuss new concerns, data, initiatives, and projects

- V. Division of Early Childhood Updates: Cyndi Lessner (1:45-2:00)
  - A. Build a Plan Recovery Guide

1. Cyndi reported the update on the guide as she provided a walk through on the website. The team is working to develop an interactive guide. They will include recommendations and regulations within the guide for programs' daily routines. Phase Two of the guide will look to support Head Start and Judy Center programs.

VI. Infant & Early Childhood Mental Health Services Survey: Margo Candelaria (2:00-2:15)
 A. Margo provided history of relationship with IECMH with MSDE DEC and DEI/SES, especially Part C Services (MITP). The IECMH survey is an attempt to get a statewide picture

of related activities including screening practices, timelines for addressing social-emotional concerns, building staff capacity, and referral practices. The survey was sent to all MITP directors on Wednesday, December 12, 2020.

VII. Pritzker Award: Felicia Jones, PN3 Project Director (2:15-2:45)

A. Felicia Jones provided an overview of <u>Building Better Beginnings</u> which was launched in November 2020. The goal is for the programs serve at least 1 million low-income infants, toddlers, and their families by 2023. This an interagency project including MSDE, MDH, and local agencies. The grant is for 3 years, but allowed 5 years to attain its goal. Major policies will be developed to advance equity and remove barriers. There are four key goals to address these policies.

VIII. Division of Early Intervention and Special Education Services (DEI/SES) Early Childhood Updates: Janette Guerra (2:45-3:00)

A. Janette provided an update on the MITP public awareness campaign which includes public service announcements running on Maryland Public Television and social media bursts to inform the public the State's Infants and Toddlers programs are open for referrals and service provision.

B. SAFER/SATIRE authentic assessment webinar will be uploaded onto Maryland Learning Links for use across the state.

C. The MSDE ECI team will present the Inclusive Opportunities Data Landscape Webinar on Wednesday, December 12, 2020 at 10:00am for local school systems and public agencies across the state. The target audience are ITP directions, PSE coordinators, and general education early learning supervisors.

D. MSDE will continue to receive NCPMI TA – as part of the training of trainers.

E. MSDE is preparing for the new application of PDG B-5 Grants for the upcoming calendar year for the four jurisdictions.

F. MSDE is preparing SPP/APR data which will be shared to the SICC in January.

G. The team will continue with ongoing technical assistance and professional learning opportunities.
