

## Senate Bill 786 Restraint and Seclusion—Consideration and Reporting

<u>Purpose:</u> Senate Bill 786 requires the State Superintendent to convene a task force on restraint and seclusion. The task force will consider a number of assigned topics related to restraint and seclusion, review existing provisions in the Code of Maryland Regulations (COMAR), and make recommendations to the State Board and the General Assembly by October 1, 2017.

### Welcome and Introductions by Taskforce Chair

Dr. Deborah Nelson opened the meeting with a warm welcome to all in attendance. Dr. Nelson introduced Dr. Sylvia Lawson, Deputy Superintendent for School Effectiveness, who shared remarks and sentiments of thanks on behalf of Dr. Karen Salmon, State Superintendent. Dr. Lawson briefly explained the purpose and scope of work for the assembled task force.

Mrs. Mary Gable, Assistant State Superintendent, welcomed the task force and asked everyone to introduce themselves and share their professional role outside the taskforce. Following taskforce introductions, Mrs. Gable asked members of the public and members of the Maryland State Department of Education (MSDE) Division of Student, Family, and School Support (DOSFSS) to introduce themselves and share their professional roles.

### Taskforce Purpose – Rationale, Activities, Outcomes

Dr. Nelson reviewed all the folder content and explained each document in more detail. Dr. Nelson shared that electronic versions of all the materials were accessible via the <u>Link to the</u> <u>MSDE website for the Restraint & Seclusion Taskforce</u>.

Dr. Nelson reviewed the meeting topics for each of the four scheduled meetings reading the special considerations associated with each. Dr. Nelson explained that one of the primary goals of the taskforce was to potentially recommend new legislation regarding restraint and seclusion for both public and nonpublic schools.

Dr. Nelson reviewed the taskforce deliverables providing a due date for each.

# <u>Review of existing State regulations (COMAR) for Restraint and Seclusion – Prohibitions and Authorizations</u>

Dr. Nelson read aloud the current Code of Maryland Regulations (COMAR) pertaining to restraint and seclusion calling special attention to the language used for their development. Dr. Nelson explained that it would be a key objective of the taskforce to thoroughly review the regulations for the purpose of making potential recommendations for changes. During this segment the taskforce read over the regulations individually preparing to discuss them in more depth in small groups.

Before transitioning to the next agenda item, Mrs. Mary Gable introduced Senator Craig Zucker, Bill sponsor, to share remarks about the Bill and the work of the taskforce.

### Prohibitions for Restraint and Seclusion

Dr. Nelson requested the taskforce to form four smaller groups to discuss the following questions in more detail:

- 1. When should restraint be prohibited?
- 2. When should seclusion be prohibited?
- 3. Should the COMAR regulations for the prohibitions of Restraint and Seclusion be changed?
- 4. If so, what should the new regulations address?

The small groups discussed the questions for twenty minutes and prepared separate lists of questions and special considerations. After small group deliberations, Dr. Nelson asked each group to report out on their major discussion points and lingering questions related to the material. Group responses were recorded on flip-chart paper and in the electronic meeting notes.

The taskforce briefly adjourned for a five minute break and reconvened promptly at 2:37 PM. The taskforce returned to their previous small groups to discuss the next items on the agenda.

## Authorization for Restraint and Seclusion

Dr. Nelson provided four additional questions for the small groups to consider:

- 1. When should restraint be authorized?
- 2. When should seclusion be authorized?
- 3. Should the COMAR regulations for the authorizations of Restraint and Seclusion be changed?
- 4. If so, what should the new regulations address?

The small groups discussed the above stated questions for twenty minutes preparing separate lists of questions and special considerations. Following small group deliberations, Dr. Nelson asked each group to report out on their major discussion points and lingering questions related to the material. Group responses were recorded on flip-chart paper and in the electronic meeting notes.

Key Areas Discussed by the Taskforce

- Review of existing State Regulations (COMAR) for Restraint and Seclusion— Prohibitions and Authorizations
- Prohibitions for restraint and seclusion
- Circumstances under which restraint and seclusion shall be prohibited
- Schools, or types of schools, in which restraint and seclusion shall be prohibited
- Authorization for restraint and seclusion
- Contraindications for restraint and seclusion
- Who may authorize restraint and seclusion
- Medical contraindications and associated implications
- The role of clinicians, physicians, and other notable medical experts in providing guidance to schools and districts about appropriate measures of restraint and seclusion
- Training requirements, standards, and accountability measures that could be enforced for restraint and seclusion
- Debriefing models, standards, and practices that could be established following an incident of restraint and / or seclusion
- Further clarification on current COMAR regulations pertaining to restraint and seclusion

Dr. Nelson asked if anyone from the public wished to make any comments. No one from the public desired to comment.

Dr. Nelson reminded the taskforce about the next meeting date and the assigned homework to complete before Wednesday, August 2<sup>nd</sup>.
