# **PURPOSE:**

To obtain permission to adopt the revisions to the *Maryland Student Records System Manual Final* 2016 (MSRSM) (Attachment I), 2016 which are incorporated by reference in COMAR 13A.02.06.02, 13A.08.01.01, and COMAR 13A.08.02.01. The proposed amendments to COMAR that update references to the MSRMSM.

### **REGULATION PROMULGATION PROCESS:**

Under Maryland Law, a state agency, such as the State Board, may propose new or amended regulations whenever the circumstances arise to do so. After the State Board votes to propose such a regulation, the proposed regulation is sent to the AELR Committee for a 15-day review period. If the AELR Committee does not hold up the proposed regulation for further review, it is published in the Maryland Register for a 30-day public comment period. At the end of the comment period, MSDE staff reviews and summarizes the public comments. Thereafter, MSDE staff will present a recommendation to the State Board of Education to either: (1) adopt the regulation in the form it was proposed; or (2) revise the regulation and adopt it as final because suggested revision is not a substantive change; or (3) revise the regulation and re-propose it because the suggested revision is a substantive change. At any time during this process, the AELR Committee may stop the promulgation process and hold a hearing. Thereafter, it may recommend to the Governor that the regulation not be adopted as a final regulation or the AELR Committee may release the regulation for final adoption.

# **HISTORICAL BACKGROUND AND PURPOSE:**

The MSRSM provides direction and guidance for completing and maintaining an accurate history of the performance of a student during their years of school attendance. The most recent revision of the Maryland Student Records System Manual was in 2011. Statutory and regulatory guidance has been issued revising how schools must provide for systems of enrollment, attendance, and promotion. These systems are delineated in the manual and the MSRSM becomes a working tool for the

processes for maintaining student records. The purpose of this presentation is to review proposed revisions to the MSRSM 2011, which are incorporated by reference into State Board of Education regulations at COMAR 13A.08.02.01.

During 2014 and 2015, stakeholder workgroups reviewed, updated, and provided substantive guidance forming the revisions of the MSRSM. Members of the workgroups included representatives from Local Education Agencies (LEAs) as well as staff from four Divisions within MSDE: Division of Curriculum, Assessment and Accountability; Division of Student, Family, and School Support; Division of Special Education/Early Intervention Services; and Early Childhood Development. In addition, the MSRSM was circulated to all divisions for review and comment.

There are four main categories of changes and updates which affect the MSRSM: updated language to improve clarity for LEAs in gathering data; updated language to align with amended policy and/or regulations; reflect changes in procedures at MSDE; and remove redundant statements. Significant revisions reflect changes in the Maryland Guidelines for a State Code of Discipline (July 22, 2014).

At the May 2015 Maryland State Board of Education Meeting, permission was granted to publish the *Maryland Student Records System Manual Final 2016* (MSRSM) (Attachment I), 2016 incorporated by reference in COMAR 13A.08.02.01, COMAR 13A.08.01.01E, COMAR 13A.02.06.02B(9). Opportunities for public comment were provided through publication of the proposed amended regulation in the Maryland Register, Volume 42, Issue 23, Friday, November 13, 2015 (Attachment II).

## **EXECUTIVE SUMMARY:**

The MSDE received comments and questions from the Maryland Association of Nonpublic Special Education Facilities and Advocates for Children and Youth (Attachment III). The comments and question received were: 1) questions regarding reasons for lawful absences; 2) questions regarding coding for students in incarceration or in detention; and 3) comments expressing suggested revision to the MSRSM discipline section to replicate the MSDE Maryland Guidelines of a Student Code of Discipline.

The proposed non-substantive amendments, as revised: (1) corrects a grammatical error to ensure that a sentence in the discipline section reads correctly; (2) corrects regulation citations to ensure complete references to the appropriate State Laws and Regulations.

#### **ACTION:**

Request permission to adopt COMAR 13A.02.06, 13A.08.01, and 13A.08.02 to incorporate by reference the Maryland Student Records System Manual Final 2016.

The proposed action has no economic impact.
