SUBJECT: Update on BOOST Scholarship Program for 2017-2018

PURPOSE:

This item is to provide an update on the Broadening Options and Opportunities for Students Today (BOOST) Scholarship Program for 2017-2018.

BACKGROUND/HISTORICAL PERSPECTIVE:

The BOOST Program provides scholarships for students who are eligible for the free or reduced-price meal program to attend eligible nonpublic schools. For 2017-2018, the program is governed by language in House Bill 150 of the 2017 session (the Fiscal 2018 Budget Bill).

As required by House Bill 150, students who received a BOOST scholarship in 2016-2017 and are still eligible are given priority in receiving 2017-2018 awards. Among new applicants, students who attended a public school in 2016-2017 are given priority. The BOOST Advisory Board also determined that students with lower household incomes who qualify for free meals should be given priority over students who qualify for reduced-price meals.

SUMMARY:

Attachment A shows a summary of the scholarships that have been awarded and accepted as of October 2, 2017. Attachment B shows the same information by the applicants' county of residence.

A total of \$6.1 million is available for the BOOST Scholarship Program for 2017-2018. As of October 2, 2017, \$5.5 million has been awarded. The Maryland State Department of Education (MSDE) is working with participating schools to confirm enrollment of BOOST awardees. MSDE will continue to issue scholarship awards as directed by the BOOST Advisory Board. The next group of awardees will be eligible applicants who qualify for free meals and attended private school in 2016-2017. The awards will be issued so that applicants with the lowest household incomes are served first.
