Assessment Results

Purpose

To provide a briefing from NASBE to the State Board on the aggregate results of a self-assessment survey taken by the Board in the spring.

Background/Historical Perspective

In March 2023, the State Board began a self-assessment process through an opportunity offered by NASBE. This process concluded with the completion of a survey provided to the State Board in April 2023 that covered several topics related to Board operations, functioning, and policy focus. The goal was to collect an overall internal assessment of the Board's adherence to its mission, priorities, and goals.

Executive Summary

Maryland State Board of Education Self-Assessment Survey Results

Prepared by the National Association of State Boards of Education May 2023

Purpose

As with any organization, a state board of education can often benefit from a look in the mirror, and an honest assessment of how effectively and productively the board is performing. A well-designed self-assessment allows a board to identify strengths as well as improvement opportunities that can inform its future practices and actions. Such reflection ensures that the board of education maintains fidelity to the common mission of providing educational excellence with equity for all students.

Process

The self-assessment evaluation for the Maryland State Board of Education is based on feedback from individual board members regarding their overall board effectiveness. Individual board members ranked a series of reflection statements by stating whether they strongly disagree, somewhat disagree, somewhat agree, or strongly agree. The statements align to four categories:

- Mission, Priorities and Goals (9 questions): The board has defined its mission and developed priorities and goals. The Blueprint for Maryland's Future plan is integral to defining the direction for the future of education in Maryland. These questions gauge the extent to which the board's work reflects those defining ideas.
- **Agendas, Meetings and Support (12 questions):** This category reflects the mechanics of how the board operates, so that it can work efficiently and with focus.
- **Collegiality and Collective Voice (5 questions):** Boards work best when members engage collaboratively and feel comfortable expressing their perspectives.
- Stakeholder Engagement and Public Interaction (9 questions): How the board collects and seeks feedback from the community and other agencies and uses this to inform board work matters greatly. These questions probe board members' perceptions on the type, degree and amount of public engagement.

An additional three open-ended questions were included at the end of the survey asking about overall impressions of the board's work.

Report Contents

The best approach to processing the information in this report is through review and discussion by board members. To help inform those discussions there are three parts to this report. First is this introduction which includes a short set of "**Observations**" at the end. The observations are meant to be a very high-level factual synthesis of the responses. Next, the "**Snapshot**" is a one-page compilation of all the questions and the percentage of responses by category for each. This allows

for a quick scan of all responses in a relatively concise format. (For reference, Appendix A include the exact wording for all questions.) Following the "Snapshot" are the **open-ended questions** (questions 11, 24, 30, 40, 41, 42, and 43) of the survey with responses presented verbatim. For these open-ended questions, highlighting is used to indicate the primary idea(s) in each response to facilitate the identification of patterns.

Respondents

Twelve Maryland State Board of Education members completed the Self-Reflection Survey between April 14 and April 28, 2023.

Observations

The following are some neutral, aggregate response-based observations:

- One statement received 100% of members responding "strongly agree" (priorities consistent with pillars of *Blueprint for Maryland's Future*). All board members responded "somewhat agree" or "strongly agree" on 12 questions; board members showed the strongest overall agreement for items in the Mission, Priorities, and Goals category.
- One or more board members responded "strongly disagree" on 11 statements.
- Seven questions had 15% or more of respondents marking "somewhat disagree" or "strongly disagree." The majority of these (4) are in the "Agendas, Meetings, and Support" category.

The following are the questions that were used for the self-assessment by the Maryland State Board of Education.

Respondents were given five choices for response (Strongly Disagree, Somewhat Disagree, Somewhat Agree, Strongly Agree, and Insufficient Knowledge). A few questions were open ended, as indicated.

Mission, Priorities and Goals

- 1. Please enter your name below (OPEN ENDED)
- 2. I have a solid understanding of *our board's* mission and vision.
- 3. Our board sets goals that are appropriate to the needs of Maryland's students and schools.
- 4. Our board sets goals that focus on evidence-based decision making.
- 5. Our board sets goals that are based on disaggregated school, district, and state data where appropriate.
- 6. Our board focuses on equity in all decision making.
- 7. Our board seeks and uses high-quality data to inform all decisions.
- 8. Our board communicates well with the state superintendent of schools on mission and goals.
- 9. State stakeholders understand and are supportive of our board's mission and goals.
- 10. The board's priorities are consistent with the pillars of the Blueprint for Maryland's Future.
- 11. Reflecting on your answers above, what are your recommendations for improving the state board's focus on mission, vision, and goals? (OPEN ENDED)

Agendas, Meetings and Support

- 12. The meeting agendas reflect our role as the citizens' voice in education in accordance with our authority.
- 13. The meeting agendas reflect our board's mission and goals.

- 22. I receive support needed to make informed policy decisions.
- 23. The Board is served well by the staff of the Department of Education.
