### Push to Pre-K- Education and Outreach



A voluntary initiative that helps child care providers build capacity and reduce barriers so they can apply for the State Pre-K Expansion Grant.

- + 751 new private provider seats in the 2024-2025 school year
- 56% increase in the number of applicants to pre-K expansion between fiscal years 2024 and 2025

## **Judy Center Early Learning Hubs**

Judy Center Early Learning Hubs are located in public schools and are designed to prepare children for success in school and life through multi-generational family engagement.



For the 2023-2024 school year, Judy Center Early Learning Hubs provided services to 17,681 children across 86 sites.


Since 2013, Maryland EXCELS has been building capacity for high-quality early care and education program across Maryland.

### Maryland EXCELS Bonus Distribution

Programs receive a bonus each time they improve their quality rating.

Bonus amounts range between \$1,000-\$13,500 depending on program type, capacity, and published quality rating.

Bonuses are spent at the program's discretion. They are frequently used to purchase new learning materials, update furniture, and pay for benefits for staff.

## Accomplishments in Early Childhood

- Maryland was a pilot state for Military Child Care in Your Neighborhood PLUS program to provide fee assistance to military families, leading the nation in participation numbers and children served, along with Virginia.
- Child Care Career and Professional Development Fund has 422 students currently receiving tuition assistance in early childhood-related education programs.
- As of March 2025, 97 new licensed child care programs opened this year, adding 1,521 child care spaces to meet the demand for care and early learning.
- Child care providers receiving Advance Payment through the Child Care Scholarship Program experienced a shortened True-Up reconciliation process, from three months to one month.
